

Finding Hope in Our Darkest Hours



I think I'm like most Connecticut residents who woke up early on Thurs., Oct. 13 to see horrible news that two Bristol Police Officers, Lt. Dustin DeMonte and Sgt. Alex Hamzy, had been killed in the line of duty during a heinous attack the night before that also left a third Officer, Alec Iurato, seriously injured.

Simply put, it felt like a gut punch.

As details emerged about the personal lives of

brave officers DeMonte and Hamzy, I couldn't stop thinking about the depths of grief that lie ahead for their families, friends, co-workers and citizens whose lives they impacted in a positive way. Upon hearing the news, I reached out a few of my legislative colleagues who serve Bristol. They, too, were trying to make sense of a senseless crime through the lens of their deeply personal connections to their community.

It was, and is, heart-wrenching.

Anyone who's followed the General Assembly over the last couple of years will know that law enforcement has been a significant topic of discussion and legislative action, and from where I sit that action has made officers' jobs harder.

With Election Day just around the corner, I have no doubt that vigorous debate about the impact of our state's "police accountability" law will resume soon.

Many Connecticut law enforcement officers I've spoken to feel as though their state government become an antagonistic force that has sparked an undercurrent in policymaking, one where criminals are increasingly viewed as victims while police officers are treated as if they're the enemy.

I think they're correct to feel as though that type of attitude is having a negative impact here and afar.

The National Fraternal Order of Police reports that as of Sept. 30 there have been 252 officers shot in 2022, 50 of whom were killed by the gunfire. It's a 5 percent increase from this time a year earlier. The organization reports that 93 officers were shot in 63 separate ambush-style attacks, with 24 cops killed by gunfire. Like the horrific ambush attack on officers DeMonte, Hamzy, and Iurato in Bristol, these statistics are a stark reminder of the danger that officers face when they put on their uniforms each day.

In the wake of the tragedy in Bristol, I've found inspiration and positivity in the nationwide outpouring of support for the officers' families and their department colleagues.

I'm guessing that many of you who are reading this feel similarly.

In the final moments of the heartbreakingly beautiful funeral services for Lt. DeMonte and Sgt. Hamzy held at Rentschler Field, the pastor who closed the ceremony prayed to God, hoping that some good could eventually be drawn from the ultimate sacrifice associated with this tragedy. I hope so, too.

Crime Rates in Connecticut

Dear Editor:

"Crime in Connecticut," a September report by the Department of Emergency Services, tries to tell us that "crime decreased last year across most categories, continuing a broad trend stretching back decades." A review of this Report compels questions of its authenticity and bias.

An authentic statistical analysis is the result of a reliable process aimed at discovering and assessing meaningful facts. This annual Report is the result of 1970s FBI procedures mutated for half a century by Connecticut's unique politics. While we expect such a study to count crime by unsullied numbers of complaints, arrests and convictions, this Report proudly announces that it considers obtuse factors such as: (1) economic conditions; (2) attitudes of citizens toward crime; (3) unemployment; (4) cultural conditions; (5) citizens crime reporting practices and (6) climate. Do these relate to any actual statistical incidence of crime, or do they suggest a political agenda? Most suspect about the Report is the fact that it considers these spurious factors yet fails to assess the rate-skewing dynamics of "defund the police," Connecticut's Police Accountability Law and "rogue prosecutors." While not all of these things necessarily occurred by and large in Connecticut, the failure to address them render the Report highly suspect.

The defund the police movement simultaneously sought to reduce and discourage the enforcement of our laws. Less police and less incentive to prevent crime naturally resulted in less arrests and less convictions, decreasing the measured rate of crime. Far from any decrease in crime, when police stood down, people raided businesses and freely stole what they could in a frenzy of theft and destruction that didn't register as crime.

Prior to Connecticut's Police Accountability Law, the police had "qualified immunity." They were never exempt from liability; they were wholly accountable for their actions whenever they should have known they would and did violate the established

Did you know that Connecticut is one of only 4 states with just one day of in-person voting? Yes, only four. The other three States are Mississippi, Alabama and New Hampshire. You have the power to change this!

On November 8, voters will have the opportunity to give our legislators permission to amend our constitution to allow for Early In Person.

What's this all about?

In 2021, the Connecticut legislature agreed, in a bi-partisan vote, to put this Early Voting Referendum on the November Ballot:

"Shall the Constitution of the State be amended to permit the General Assembly to provide for early voting?"

Our election laws are part of our state constitution, so to make In Person Early Voting a reality, eligible voters must vote "yes" on the referendum question November 8. Once the referendum passes, it will be up to our elected state representatives to craft the plan for how we will conduct Early Voting in Connecticut.

The ONLY thing the Referendum is asking you to decide is: Do you agree with the idea of amending the Connecticut Constitution to allow for early in-person voting? If you do, then vote YES. A yes Vote will give the legislature permission to decide the mechanics of creating Early In Person voting in our state.

Naysayers will profess concerns about voting yes when we don't know how many days will be allowed. That is the whole point. We want to allow the legislature to decide what makes sense for our State in consideration of any costs involved and logistical concerns. We trust our legislators, who we elect, to make all kinds of decisions regarding our health, safety, environment, etc.

A "yes" vote on the Early Voting question will give voters who want to cast their ballot in-person, but can't make it to the polls during the hours of voting on Election Day, another in-person option.

Depending on what town you live in, it might appear on the back of the ballot – look for it and vote YES for the freedom to vote early in-person!

Let's give Connecticut voters more freedom to participate in our democracy.

rights of any person. Without qualified immunity police officers have every reason **not** to enforce the law whenever an honest mistake might get them sued (i.e., most of the time). Their failure to act results in less measured crime but no less crime.

The Report also fails to assess the effect of Progressive "rogue prosecutors" who refuse to pursue entire categories of crime. It states that crimes are not counted when prosecutors don't to seek an arrest warrant. Albeit crimes are committed, the refusal to charge lowers the measured rate, e.g., when prosecutors refuse to charge illegal aliens, ANTIFA marauders, BLM and stand-down rioters.

The suggestion that the Democrats' politics have decreased the crime rate to any extent is a biased manipulation of statistics. Democrats have now been forced to claim they never called to defund the police. This Report is just part of that effort to cover their tracks by manipulating the narrative.

Do not eliminate a person because you think they do not have a high enough net worth. It is your job to financially plan for your children. Recycling News

North Branford Fall Leaf Collection.

North Branford residents can bring their leaves to the leaf drop off center located to the left of the police station, near the Public Works Facility on Route 22 from 9:00am to 3:00pm on Saturdays October 29th, November 5th, 12th and 19th. Just follow the signs. No brush or grass clippings. Please place leaves in biodegradable leaf bags (no tape please) or empty them loose onto the ground.

There will be a curbside pickup of leaves in untapped biodegradable paper bags the weeks of November 28th – December 9th

Bulky Waste Pickup is only twice a year. The next pickup is the week of November 7th. Please do not place your bulky waste curbside until that week.

For items that still have some life in them, consider posting them on the Facebook page: North Branford & Northford Free Items. Help someone else out, unclutter your house and save the cost of sending items to the landfill.

Electronics Drop Off will be on Saturday November 5th. The event will be held at Public Works from 9am to noon. Take2 Recycling will be collecting electronics such as TVs, computers, small appliances and almost anything that has a plug. They cannot accept smoke detectors, A/C's or dehumidifiers.

We will also be taking MATTRESSES (clean and dry), BATTERIES and USED OIL for free.

There is a small fee for recycling **PROPANE TANKS** in reusable condition and TIRES.

When you bring us your mattress, you are creating jobs for those who take them apart to recycle the components.

Hazwaste Central will be closing for the year on 10-29th.

Located right behind the Regional Water Authority's headquarters, 90 Sargent Drive, New Haven Hours are Saturdays from 9am to noon.

Household hazardous waste comes from everyday products used in the home, garage, yard or garden.

Smoke Alarms, Change Your Clocks, **Change Your Batteries**

If I asked you where your smoke alarms are in your home, could you tell me? If you are like many people, you may not pay much attention to where smoke alarms have been installed. However, location matters when it comes to smoke alarms.

Smoke alarms should be installed inside each bedroom, outside each sleeping area and on every level of the home, including the basement.

Working smoke alarms are a critical fire-safety tool that can mean the difference between life and death in a home fire. According to the nonprofit National Fire Protection Association (NFPA), smoke alarms can cut the chance of dying in a home fire in half. Meanwhile, NFPA data shows that home fires killed 2,755 people in 2018, an average of eight people every day that year. Many of these deaths could have been prevented with the proper smoke alarm protection.

As a member of the fire service, I have seen the devastating effects of fire firsthand; the burn injuries, the loss of homes and possessions are distressing. What is even worse is witnessing a family's anguish after a loved one has been killed in a fire. It is heartbreaking.

My sincere hope is that all North Branford residents make sure there are working smoke alarms installed throughout their homes. These simple steps can help make a lifesaving difference and prevent the potentially life-threatening impact of fire.

Here are additional smoke alarm tips to follow:

- Install smoke alarms in every bedroom, outside each separate sleeping area and on every level of the home, including the basement.
- Interconnect all smoke alarms throughout the home. When one sounds, they all sound.
- Test alarms each month by pushing the test button.
- Replace all smoke alarms, including alarms that use 10-year batteries and hard-wired alarms, when they are 10-year-old or sooner if they do not work properly.
- Make sure everyone in the home knows the sound and understands what to do when they hear the smoke alarm.
- If the smoke alarm sounds, get outside, and stay outside.
- Go to your outside meeting place. Call the fire department from outside

Please Display Your House Numbers

Please help us help you. Sometimes it can be difficult to find the proper address when responding to an emergency. Please have proper house numbers that can be viewed from both directions on the street.

- 1. At least 4 inches in height, in a contrasting color to the background
- 2. Visible from the street
- If the building is set back by more than 100 feet, the number should be affixed to a post or mailbox not more than 10 feet from the driveway


