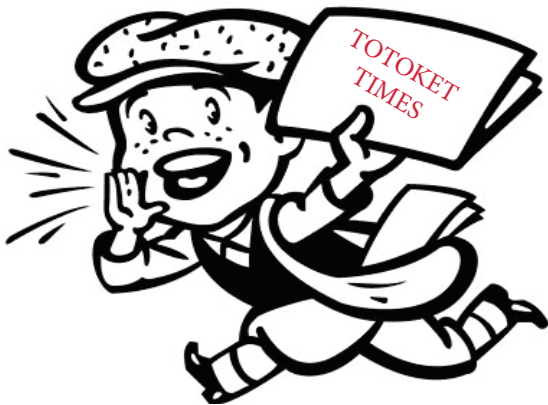

State Representative Vincent Candelora Problems in State Government Are Piling Up



It's been a rough couple of weeks for Connecticut state government. The steady drumbeat of scandals, mismanagement, and accountability failures should make clear to officials who would like to brush off what's transpiring that these issues can no longer be ignored. Government needs a hard reset.

Last week, the state's Department of Motor Vehicles finally fired an employee who had been using his position to personally profit from towed vehicles—nearly five years after investigators uncovered the scheme. The DMV worker traded favors with a towing company, letting them skip DMV lines in exchange for the ability to buy towed cars at deeply discounted prices, which he then resold for thousands of dollars in profit. That it took five years to relieve the individual from his position is an embarrassment in bureaucracy.

Spending in our state colleges and universities system received more media coverage recently when state auditors revealed that Eastern Connecticut State University was missing documentation for more than \$100,000 in expenses and contracts for the 2023-24 fiscal year. Unsurprisingly, purchase card transactions were also an issue. Thankfully, the legislature has dug into the issue of lax financial controls at schools—it rose to prominence after the former \$450,000 a year chancellor's spending abuses—and is scrutinizing the problem.

Meanwhile, former state Representative Christopher Ziogas pleaded guilty to bribery charges, admitting he delivered thousands of dollars in bribes to former state budget official Kosta Diamantis to kill a Medicaid audit of his fiancée's optometry practice. It's been one of the less-heralded federal corruption stories, though he faces a maximum of 55 years in prison. Diamantis, already convicted on separate bribery charges related to school construction contracts, now faces trial in February.

The federal investigation into state nonprofit funding keeps uncovering problems. This week revealed that the Department of Economic and Community Development was warned in 2023 about a conflict of interest involving Senator Doug McCrory but failed to inform the Governor or State Ethics office. A nonprofit director reported "political coercion" over a \$5 million grant split with McCrory's associate—a concern that apparently didn't get the attention it deserved at the time.

Adding to the rough week was an embarrassing set of emails obtained through a Freedom of Information request of the Attorney General's Office, which has marketed itself as the paragon of virtue in state government. Office employees made derogatory comments about a whistleblower who had filed discrimination complaints against state agencies and searched for personal information to find liens against him. Aside from being unprofessional, such conduct directed at a whistleblower raises serious questions about how the office handles sensitive matters.

These aren't isolated incidents. They reveal a pattern: corruption and controversy thrives when there's no transparency, no oversight, and no consequences. Investigations languish for years. Whistleblowers get mocked instead of protected. Warnings about conflicts of interest get ignored. Basic documentation requirements are treated as optional.

I've been pushing for comprehensive reforms—demanding transparency in how tens of millions of dollars in grants are distributed, requiring public hearings and audits, and insisting on real oversight of state agencies.

When the legislature re-convenes in February, I hope Republican accountability proposals—including an expansion of duties for the state's inspector general—will get the consideration they deserve. Particularly given what we're seeing in the news media.

Connecticut taxpayers deserve better. It's time for real change.

Our friend Cathy is 92 and she still is able to have a glass of wine a day and as she put it, "once a week, two fingers of scotch with one ice cube.

The ways of the church still baffle me. Although not a Holy Day of Obligation, when we were kids one church had two or three Masses to give the people an opportunity to properly thank the Lord for our gifts. Now with more than four or five churches in a single parish, most parishes only had one Mass for the family of parishioners. Some of us adjust. I relax and reflect at the cemetery but many do not. Another discouragement with no formal means of gathering together to express thanks and worship with our parish family. As one priest casually explained to me, "It's not about the convenience of the people". I was told the look on my face was priceless when I realized he was serious.

The day was very relaxing. It actually gave more time than usual to reflect on the great life (even with its bad times) that we really have. Out of memories to mon and Mary, we watch for the gazillionth time, the Sound of Music. I also watched bits and pieces of It's a Wonderful Life. I usually watch it in its entirety on the anniversary of mom's death, the day after Christmas.

Although quieter than most, it was a good day and I still wonder why I am still here and you and Mary are gone.

Now it's on the Christmas. Feeling better this year I will be having the usual house full for Christmas Eve. Erica and John for the first time will be hosting a multi family event on Christmas Day. On Saturday we will be

having a party with a few close friends who don't get to see Frank and Ana too often.

On Sunday I will be resting because watching SueAnn do all this work is often very tiring.

Well that's it for now. I miss all of you and obviously you at my dinner table was much better than visiting you at All Saints. I must say it is a lot quieter.

My best to everyone. Let them know I'm still doing my best to keep up traditions and the family togetherness.

Christmas Day and New Year’s Day are Trash Holidays
Pickups will be delayed 1 day after the holiday for these 2 weeks.

There will be a curbside pickup of leaves in untapped biodegradable paper bags (no tape please), the weeks of December 1 – 12.

Here are some tips for this holiday season.

Meal Planning

- Single-use paper plates, cups, napkins and utensils all belong in the trash.
- Shop smart to avoid throwing away excess food.
- Compost your food scraps.

Gift Giving

- Think outside the box – purchase experiences, memberships or donating to a non-profit on behalf of a friend or family.
- Check out local thrift and consignments stores for holiday gifts.
- Shop local to support your local economy.

Please recycle the packaging that your holiday shipments arrive in.

- Cardboard shipping box - recycle bin
- Styrofoam – trash bin
- Bubble wrap – plastic film drop-off location
- Shipping envelopes (plastic in and out) – plastic film drop-off location
- Shipping envelopes (mixed materials) – trash bin
- Plain cardboard gift box - recycle bin
- Plain wrapping paper – recycle bin

If you aren’t sure if it should go into the recycling or trash, put it in the trash.

Don’t put your recyclables inside a cardboard box or plastic bag.

Recycling should always stay separated and loose.
