The first fundraiser was held in 1998, when Mary Caruso's children, Sam and Alex Bode, were first diagnosed with Friedreich's Ataxia (FA)—a progressive neuromuscular disease. Now, 25 years later, a treatment to slow the progression of this disease has finally received FDA approval, yet the family continues with the same determination and optimism to find more treatments and, ultimately, a cure for FA.

With great excitement, they will return to the Owenego Inn, 40 Linden Avenue, Branford. The event will begin at 6 p.m. with hors d'oeuvres followed by dinner and a cash bar. There will be a raffle, as well as silent and live auctions. Attendees will be offered various disciplines of holistic practitioners, all of which Sam and Alex utilize in their lives. "We are grateful to our practitioners offering their services to our guests. We hope someone will try something new that can help them in their life," says Alex. "Most of the holistic work we get helps us find our courage to succeed."

Many obstacles that Sam and Alex faced this year helped develop the theme of Living a Courageous Life. As Caruso explains, "Sam and Alex find their way to the level of courage they need and we know everyone struggles in life and each person has to find their level of courage also. We are hoping this year's theme and the take-home gifts we have for our attendees will help anyone who needs to find their courage."

About FA

Friedreich's ataxia (FA) is a debilitating, life-shortening, degenerative neuro-muscular disorder. About one in 50,000 people in the United States has FA, with most having onset of symptoms between the ages of 5 and 18. Adult, or late-onset, FA is less common (less than 25 percent of diagnosed individuals) and can occur anytime during adulthood.

The signs and symptoms of Friedreich's ataxia are:

loss of coordination (ataxia) in the arms and legs

fatigue, energy deprivation and muscle loss

vision impairment, hearing loss, and slurred speech

aggressive scoliosis (curvature of the spine)

diabetes mellitus (insulin-dependent, in most cases)

serious heart conditions, including hypertrophic cardiomyopathy and arrhythmias. The progressive loss of coordination and muscle strength leads to motor incapacitation and the full-time use of a wheelchair. Most young people diagnosed with FA require mobility aids such as a cane, walker or wheelchair by their teens or early 20s.



## State Representative Vincent Candelora



Police respond to a reported broad daylight carjacking and use road spikes to stop the flee-ing vehicle. It eventually crashes and one of the two suspects flees to a nearby auto tire business, fights with an employee inside a vehicle as he tries to steal it. The employee flees and an officer deploys his K-9 into car, and when the officer gets inside to retrieve the police dog and arrest

the perpetrator, the man ignores commands to stop and takes off with the cop and K-9 along for the ride. The owner of a detail shop nearby hears screeching tires and runs out of his business to see a car barreling through piles of tires as bystanders scurry. The shop owner hears shots and hits the ground before the vehicle crashes into a telephone pole. The suspect dies, while his partner in crime, a convicted felon with 30 arrests to his name, is taken into custody.

No, this isn't an excerpt from a movie script. It isn't Los Angeles, or even Chicago—this harrowing scene exploded in West Hartford, and I don't blame Connecticut residents who fear that it is emblematic of the new normal in the Nutmeg State.

Who could blame them?

Hours earlier, a man already out on bond after allegedly shooting an innocent bystander in a retaliatory attack in 2021, allegedly killed one person in Hartford and injured another. Before that, a child was shot outside a hospital in New Haven. And as I type this, news is surfacing of a 48-hour crime spree that ended in Meriden with a crashed police cruiser and suspects who torched one of three stolen vehicles.

These crimes, and many others, have occurred on the heels of an article in the progressive publication Slate, which had many of my Democratic colleagues crowing that Connecticut had done something remarkable—policy-wise—to mothball several of its prisons.

Tell that to the family of the man allegedly killed in Hartford by the guy who was roaming around free on bonds totaling more than \$800,000.

By and large, my Democratic colleagues in the legislature have brushed off all these headline-grabbing crimes that have the rest of Connecticut talking.

Crime, they say, will always exist. It's a part of life. Our majority party friends have even taken to figure-pointing Republicans, criticizing my caucus colleagues for voting against a measure to amend the constitution to allow a judge to hold the most dangerous individuals, like the Hartford shooter, without bail. Conveniently, they neglect to mention their proposed amendment would likely lead to the elimination of cash bail altogether, meaning just about everyone else—plenty of bad apples included—would be roaming the streets pretrial.

Expect to hear a lot more about New York City-style "bail reform" in the coming months.

In the meantime, continue to lock the doors to your houses and vehicles. Kids are still breaking into and stealing vehicles, like the 12-year-old and two 13-year-olds who made headlines in Trumbull two weeks ago. After their failed attempt to steal a woman's vehicle—of course, they damaged it—the preparators were released to the custody of their parents. The youngest of the three was already on probation on car theft-related charges.

Between Jan. 1 and June 30, there have been a staggering number of juvenile arrests related to motor vehicle theft—604 minors were charged, compared to 269 over the same six-month period last year and the overall 628 in 2022. The 2020 record of 888 is, unfortunately, in sight.

Juvenile "justice" advocates, loathe to admit there's a problem, point to police doing a better job keeping statistics rather than an increase in crime. For them, this is normal.

Yet the rest of us can see it with our own eyes, hear it in the experiences from our friends and neighbors, and read about it in the media.

For us, this isn't normal, and we shouldn't settle for it.

## **North Branford Awards East Haven Animal Shelter Contract**

PRESS RELEASE: The Towns of North Branford and East Haven are pleased to announce the merger between North Branford and The East Haven Animal Shelter. North Branford does not have its own shelter and had previously contracted with the Town of Branford for these services. The North Branford Town Council voted to approve the agreement at their July 18th meeting. This move signifies a promising collaboration between the two municipalities.

The agreement sets the cost of services to North Branford at \$135,000 annually for the first two years and increases by 4% annually thereafter. Additionally, the two towns agree to review call volume to North Branford after the first year of the agreement and assess if the services are accurately reflected in the charges. East Haven will take over ACO services for North Branford effective September 1, 2023.


Under the terms of the previous animal control agreement with Branford, North Branford was set to spend \$175,000 on service with an additional outlay of over \$1 million in capital funds for the facility in Branford.

"This move will keep North Branford in the hands of a top-notch, professional animal control operation that highly values animal welfare and care," said North Branford Town Manager Michael Downes. "The North Branford Town Council's approval of this agreement will save North Branford taxpayers over \$40,000 per year and eliminate the need for any capital expenditure."

East Haven's Animal Control Officer Emily Higgins commented, "This collaboration represents a leap forward in animal welfare and community development for both towns. By centralizing animal care services, we can better allocate resources, enhance adoption programs, expand access to affordable veterinary care and most importantly, conduct educational outreach to raise awareness about responsible pet ownership."

North Branford council member Nick Palladino referred to his previous work with East Haven's beloved Animal Control Officer Owen Little by saying, "I know how East Haven operates and I know how Owen Little operates, he (Owen) has such ties to the shelter, that he retired and still works part time."

Little appreciated the sentiment saying, "I'm humbled by the kind words from the North Branford Town Council and look forward to actively engaging with their residents as well." Michael P. Downes - Town Manager

## Freshman Orientation to be Held at North Branford High School





## Why Am I Getting a Bill If You Didn't Transport Me?

The State Department of Public Health sets the rate schedule for all Connecticut ambulances to abide by. In June 2021, they enacted a provision that allows ambulance services to bill patients for a "treat and non-transport" situation. We have held off implementing this in North Branford.

It is important to know that in our town, every dollar to fund the ambulance operation that doesn't come in from billing, must come from taxpayers. To that end, the "treat and non-transport" provision was recently started with our billing company – Comstar. As you can imagine, the enhancement to staff the second Paramedic ambulance - which has proven very beneficial – comes with a large financial commitment. Also, it is not uncommon for us to encounter a patient who requires us to use supplies, medications etc. and then decides to refuse transportation. These medications are costly and sometimes we have limited supplies.

If you receive one of the "treat without transport" invoices, we ask you to forward it to your insurance company for payment. If anyone has questions, please send them to firechief@townofnorthbranfordct.com

#### **Helpful Hints for Plastic Recycling**

You can keep the caps on the bottles when putting them into the blue bin. Black plastic, as in plant pots and take-out containers, are not recyclable. The sorting machines don't work on the black plastic. All other colors work fine.

#### Please don't put your bulky waste out at the curb The next bulky waste pickup isn't until November!

Construction debris (such as toilets, concrete blocks, roofing material), propane tanks, TVs, monitors, printers, home cleanouts may not be placed curbside. These items will not get picked up; please dispose/ recycle properly.

There is also <u>Freecycle.org</u> in East Haven or New Haven. You can look up your item in the **New Haven Downsizing Donation** Guide. It lists multiple organizations that want your stuff! Just Google 'New Haven Downsizing Donation Guide'. Some places even pick up large items.
