Michael Doody, 69, of Cisne, IL, formerly of Northford, CT., passed away peacefully on Sunday, August 11, 2024, at home, with his loving family by his side.

Michael was born in New Haven, CT on March 21, 1955 to the late Francis P. and Eleanor (Downing) Doody.

Michael attended the University of New Haven, where he studied criminal justice.

Michael was employed by the North Branford Police Department from 1976 to 2010, rising to the position of Deputy Police Chief before retiring. In 2011, he realized his desire to continue working, and became a driver for JP Express in

Northford, CT, a position he held until 2021, when he relocated to Illinois to start his own trucking company, White Hollow, LLC.

Michael was a devoted public servant to the Town of North Branford, CT, holding the elected office(s) of Mayor, Deputy Mayor, Town Council Member, and being an appointed member of the Agricultural Commission, Conservation Commission, Inland/Wetlands Commission, Planning & Zoning Commission, and Human Relations. He served as a youth basketball and soccer coach for his children's teams and was the past President and board member of the New England Hereford Cattle Association. A lifelong proponent of agriculture and the rural lifestyle, he was happiest attending cattle shows or sales, on his farm, helping with chores, making hay and cheering on UCONN"S Men's & Women's basketball teams.

Being a loving father and uncle meant the world to him as he was truly as selfless as they come. He always had a lot going on, but he always made time in his life for family. He worked everything like a professional. From showing cattle, to police work or his involvement in his community he was able to relate to and bring people together.

Michael is survived by his loving wife, Jo Ann (Salg) Doody; son, Michael (Dalton) Doody Jr; daughter, Melissa Doody (Angel Cintron); grandchildren, Christian Cintron, Michael Doody III, and Madden Doody, his sister, Susan (Michael) Doody-Duhamel; and brothers; Francis (Valerie) Doody III, and John (Michele) Doody; as well as a large, loving family of in-laws, nieces, nephews, and cousins.

No answer means hike is still on. Rain date September 15, same time.

## State Representative Vincent Candelora On the Heels of Rising Electric Bills, **Regulators Approve More Rate Hikes**



On Aug. 14, state utility regulators took just moments to breeze through their scheduled agenda and signed off on another \$80 million rate adjustment increase that they expect will enhance the electric vehicle industry in Connecticut, starting next month.

The Public Utilities Regulatory Authority, PURA, permitted Eversource and United Il-

luminating to collect that amount from ratepayers already struggling to pay their monthly electric bills that increased significantly in July. This EV initiative evolved as result of the policy adopted by PURA to bolster the EV charging grid.

Some in the public and media were taken by surprise at the news that the regulators were once again allowing the utilities to increase rates given the whopping rate hikes that dominated state news coverage in the previous weeks. But for those who vehemently opposed efforts by the Lamont administration last year and succeeded in blocking the mandate that no gas-powered vehicles could be sold in Connecticut by 2035, the news was particularly galling.

Republicans have repeatedly proposed solutions to the rising electrical costs by using existing surplus and other funds to mitigate the exploding costs, and have asked for a special sessional session to immediately address these issues. So far, no word from the Democrats.

The debate over EVs versus gas powered vehicles is not over. But this is not a contest between myopic Luddites desperately grasping the steering wheels of their gas-powered trucks and cars against inevitable technological advances. It's about common sense, and the common good.

#### And politics

After the PURA decision Aug. 14, Senate Democrat hastily distributed an *undated* letter asking that the vote be delayed, this after Republicans had condemned the action.

Let's briefly recount recent history:

The Lamont administration in late 2023 abandoned its initiatives to follow the California model to switch to EVs in the near future in the face of strong public opposition and the realization Lamont could not get legislation passed in the General Assembly. At the time, supporters of the switch to EVs gave up their efforts but never ceded their long-term goals of fundamentally transforming how Connecticut motorists and consumers could go about their business – getting to work, to school and generally conducting their private lives.

Of course, the major obstacle to promoting EVs in Connecticut over the last year was the realization that the state's charging grid could not support an expanded EV fleet. Never enough charging stations to supply electricity to EVs. Simple, right?

But PURA continues to promulgate policies designed to make the electric cars and trucks the reality, not just an option, for consumers. The approval of the rate adjustments last week signals that the future of transportation in Connecticut has not been decided yet.

Anyone interested in just what happened at the PURA meeting Aug. 14 and how much thought was given to the ramifications of its actions might want to check out the brief meeting here. And see the level of discourse and the body language of the three members involved.



## Disputing Candelora's Column

#### **Dear Editor:**

State Representative Vincent Candelora's editorial in the August 2nd issue of the Totoket Times contained a number of misleading and incorrect statements. It is only fair that these be responded to, and ultimately corrected. Candelora first argues that the Democrats' narrative of a democracy under attack is "worn-out." However, he also opens by mentioning the attempt on a former president, and the current nominee of the Republican party. This attack also claimed the life of one of his supporters. Democracy quite literally came under attack, so it is incorrect to say that this narrative is "worn-out." The letter then presents a series of falsehoods about this year's Democratic primary. Firstly, Candelora claims that Democrats moved the South Carolina primary first to cement Biden as the nominee. This would be rather than New Hampshire or Michigan, where he previously struggled. Candelora believes that Democrats only appreciate democracy when they can "control it from a backroom." And yet, apparently Republicans vote against national security when an unelected former president says to. The events of July 13th represent a tragic attack on democracy. Both Republicans and Democrats should be coming together to condemn it, not using it as an opportunity to decry their opponents with misleading inaccuracies. 
