# **Residential Burning Permits**

- Forms shall be available for residents to pick up at the Fire Marshal's office and Town Manager's office located at Town Hall, 909 Foxon Road. Forms are also available on the Town's website townofnorthbranfordct.gov.
- 2) Completed forms must be returned to the Fire Marshal's Office. Forms can be dropped off or emailed. Applications must be received by the Fire Marshal's office three days prior to burning.
- 3) Upon receipt of a completed signed form, the Fire Marshal's office may physically inspect and photograph the site where the brush is to be burned. **Only brush can be burned**. **No limbs over 3 inches in diameter. No stumps or leaves. Permits are issued for 30 days. Burning can only take place between 10am and 5pm**.
- 4) A copy of the completed permit will also be faxed to the North Branford Police Department.
- 5) The resident will be instructed to contact the North Branford Police Department @ 203-484-2703 on the day they wish to conduct the burn.
- 6) If complaints are received, an Open Burning Official will be dispatched to determine if a nuisance exists. If deemed necessary, the appropriate fire company will be dispatched, and the fire will be extinguished.
- 7) If the resident does not have the appropriate approval to burn, at the discretion of the open burning official or the incident commander, police intervention may be required. Pursuant to Connecticut General Statute sec. 22a-174, failure to obtain the necessary approval to burn is a Class C misdemeanor and punishable by fine of \$ 200 or imprisoned not more than six months or both.
- 8) Applicants must follow all guidelines and requirements.
- 9) You are required to have a 50-foot buffer from any structure or property line. You are required to have a water supply capable of extinguishing the fire.
- 10) Chimineas and fire pits less than 3 feet in diameter do not require a permit.

### **Please Display Your House Numbers**

Please help us help you. Sometimes it can be difficult to find the proper address when responding to an emergency. Please have proper house numbers that can be viewed from both directions on the street.

- 1. At least 4 inches in height, in a contrasting color to the background
- 2. Visible from the street
- 3. If the building is set back by more than 100 feet, the number should be affixed to a post or mailbox not more than 10 feet from the driveway.

### **Progressive Housing Policy Threatens Property Rights**



Even casual readers of the New York Post will have noticed the paper's detailed coverage of a burgeoning crisis plaguing communities throughout the country, including our neighbors in the Big Apple: landlords are finding it increasingly hard to cut ties with problem tenants, or even remove squatters, from their properties.

I fear these stories, whether derived from New York, Atlanta, or Arizona, offer snapshots of what

Connecticut's rental property landscape could look like in the future, sparked by legislation under consideration this session. Particularly, S.B. 143, *An Act Concerning Evictions for Cause*. This bill proposal from legislative Democrats would flip the landlord-tenant relationship on its head by establishing a general right for a tenant to remain in a rental unit after the tenant's lease expires.

You read it right: the end date of a lease, specified in a contract signed by both the landlord and the tenant, would be meaningless. If the tenant continues to pay rent, the property owner has but a narrow set of reasons to evict. Even then, it would require a lengthy—and costly—legal process to remove the person, with the landlord left vulnerable to a court's interpretation of nebulous reasons set forth in the bill.

There's financial risk, and headache, that comes with being a landlord. Imagine having a son or daughter who needs an apartment and being unable to move them into one of your units that should be available, but isn't, because a tenant has a right to stay when his lease expires. A tenant who plays music too loud and is a nuisance to your other tenants? Forget about parting ways without a lengthy legal battle you could very well lose. After all, who's to say a court wouldn't decide that the tenant's tunes weren't loud enough to violate a rental agreement? Meanwhile, your other rent-paying residents, frustrated by the situation, could decide to move elsewhere.

At its core, this bill is a shocking affront to the rights of individuals to do what they wish with their properties. It's a step toward creating squatter's rights—the phrase du jour from officials in other states who are frustrated by progressive housing policy.

Distorted as their approach may be, proponents of the legislation pending in Connecticut view their proposal as a means toward addressing the so-called housing shortage Democrats are also using as cover to assert state control over local land use decisions.

In reality, this bill would have an oppositive effect. It will make landlords more reluctant to rent their units. Worse even, they could choose to exit the business altogether.

With this type of destructive government intervention, who could blame them? At this point, the proposal applies to buildings or complexes with five or more units. However, most landlords know this bill is but the first salvo at their property rights. Advocates have made no secret of the fact that they want every rental property in Connecticut covered under this proposal, including a simple two-family house.

This bill passed out of the Housing Committee along party lines, with Democrats who control the panel winning the initial fight in a 9-5 vote. I'm hopeful



that this legislation will be amended—or better, fizzle completely—before the session ends.

If not, I fear Connecticut will soon be a new source of fodder for New York Post reporters covering the disturbing challenges faced by stressedout property owners. **Rep. Vincent Candelora House Republican Leader 86th District North Branford, Durham, East Haven, Guilford** 

### **For the Health of it...** The Impact of Self Care in the World of Family Caregiving



In the unavoidable chaos of family life, caregiving emerges as a profound and selfless act. It is a testament to the enduring bonds that tie us together, often manifesting in the form of parents caring for children, spouses supporting one another, or grown children looking after aging parents. It can also be all of those things simultaneously. While the commitment to care for loved ones is undeniably noble, it is crucial to recognize that the well-being of the caregiver is just as significant as that of the recipient.

The role of a family caregiver is multifaceted,

demanding physical, emotional, and mental strength. Juggling between doctor appointments, meal planning, medication management, and daily tasks, caregivers often find themselves in a perpetual state of giving. In the midst of such dedication to doing for others, it is easy for caregivers to neglect their own needs, placing their well-being on the backburner. As a former family caregiver, I know this to be true.

For many years I was the primary caregiver to two older adults, one of whom lived with us. At the time, I was starting a new career and our kids were 8 & 10. The caregiving continued for more than 15 years. "Me time" did not exist and I felt the warning signs that my health may pay the price. I was fatigued, eating on the run, forgetting appointments and at times was concerned I might fall asleep on my drive home from work. The road to burnout was right around the bend and I recognized that something had to change. I also knew I would not want to leave someone I love in the care of someone like me, who was running on empty! That's when I realized those in my care would also benefit if I would just find a way to carve out a bit of time to care for myself. It wasn't easy, but one micro step at a time, it happened. Recognizing the signs of burnout and prioritizing self-care can act as a powerful preventive measure, preserving the caregiver's well-being and the quality of care they offer.

Self-care is not selfish, it's essential. It encompasses a broad spectrum of activities that promote physical, emotional, and mental well-being. From taking short breaks to engage in hobbies to prioritizing regular exercise and maintaining a balanced diet, self-care empowers caregivers to recharge their batteries and face responsibilities with renewed energy (remember what that feels like?). It is the act of refilling one's cup, ensuring that the caregiver's compassion and dedication continue to flow and replenish on a regular basis.

Since caregiving is something that creeps up on us we tend not to even think of it as such. We're just doing what we need to do most often out of love or a sense of obligation. I remember the day I found out I was a caregiver. I was probably 4 years into the personal scenario described above, and had no idea there was a label for it, or that caregiving held any adverse potential to my own health.

Serving others is a privilege, and the impact of self-care extends beyond the individual caregiver; it ripples through the entire family dynamic. When caregivers prioritize their well-being, they model a crucial lesson for their loved ones – the importance of taking care of oneself. This valuable lesson has the potential to create a culture of mutual respect and understanding within the family, fostering an environment where each member's needs are acknowledged and prioritized.

Consider caregiving as a labor of love that thrives on the caregiver's ability to balance compassion for others with self-nurturing practices. Recognizing the significance of self-care in the caregiving journey is not an act of selfishness but an acknowledgment of the *interdependence* between the caregiver's well-being and their ability to provide effective care. As a former family caregiver, and former family caregiver consultant, I know how hard it is to take that first step towards self care and how essential it is to do so. ## Town of North Branford Inland Wetlands & Watercourse Agency Property Owner's Guide

### Why are Wetlands and Watercourses Important?

Wetlands are important features of our landscape that bring economic benefits to communities. Many people don't realize that healthy wetlands are among the most productive ecosystems on the planet. Wetlands and watercourses are part of a diverse and complex set of ecosystems that are vital to Connecticut's economy and an important part of our natural heritage.

As a property owner you play a big role in wetland protection and health. Protecting a wetland doesn't necessarily require additional effort on your part. <u>Often times it's what you don't do that's important</u>. Your most effective protection strategy may be as simple as guarding it from activities that will damage it. This may be as simple as maintaining a protective zone or buffer around the wetland to protect it.

#### **Protective Regulation**

In 1972, the Connecticut State Legislature enacted the Inland Wetlands and Watercourses Act which requires municipal governments to regulate activities affecting Inland Wetlands and Watercourses.

The State of Connecticut recommends the first 100-feet from a wetland or watercourse as an "upland review area" subject to review by the local municipality's Inlands Wetlands and Watercourses Agency (IWWA). The Town of North Branford IWWA Regulations adopted the 100-foot upland review area for all wetlands and watercourses with the exception of the Farm River which has a 200-foot upland review area.

Many property owners are often surprised to learn their property contains or is near protected wetlands. Watercourses, ponds, wetland plants and grasses are clearly recognized as wetlands. Some areas are not so obvious, requiring soil testing and flagging by a Soil Scientist to be identified.

Permitting is required before any activities can take place within or near a wetlands or watercourse and before any work can commence. There are certain uses and activities within those areas that are regulated, such as removal or deposition of soil and vegetation. Other restricted activities include obstruction of stream flow, construction, landscape alteration,pollution, removing trees, clearing brush and grasses within the wetland buffer area, directly in wetlands or on stream banks. The IWWA will grant a permit if it finds the activity will not cause harm to the wetland or watercourse.

North Branford's Farm River is a Public Water Source with significant ecological benefits.

It is vital that the land adjacent to the Farm River be protected from disruption. As with all wetlands and watercourses it is imperative that there be no introduction of chemicals, such as pesticides, fertilizers, or septic effluent into the Farm River.

It is the intent of the North Branford IWWA to work with you to responsibly develop your property to both meet your needs and that of protecting our environment. More information can be found on the Town of North Branford website or call the **Town Planner's Office at 203-484-6010**. The Town Planner has resources available, such as a town wetlands map that might indicate if your property is potentially in a wetland or adjacent to a watercourse.

### **Protective Measures**

It is imperative that all of us work together to protect our wetlands and waterways. Wetlands and watercourses are of <u>huge</u> ecological and environmental significance providing protection from floods, habitats for wildlife and aquatic animals, as well as plants which act as a carbon sink, etc.

Some measures you can take to protect our wetlands and watercourses: **Do:** 

## **Careful what You Wish For**

As Connecticut's population and industry grew in the late 1950s and early1960s, there was a great deal of pressure to convert undeveloped land to more intensive uses. Towns were rezoning farmlands, woodlands, and open spaces to conform with residential, commercial, and industrial development. As a result, undeveloped land was being appraised and assessed at much higher values than it was used for. It became increasingly difficult for landowners to continue using their land as they desired. Many folks were forced to sell their land to developers, simply because they could not afford the new tax assessments on their land.

In response, Connecticut decided to study the problem and in 1963, Public Act 490 was born. To this day, PA 490 is the single most important land use legislation in Ct's books. It provides a scale on how land is taxed by its use. This law created a level playing field for those who did not want to develop their land.

PA 490 is constantly updated to keep pace with changing times. It has several studies showing the actual costs to a town by land use. One of the studies concludes that, for every \$1.00 in taxes collected for residential development, it takes \$1.14 in services to support it. In other words, *more housing = higher taxes*. All the studies in PA 490 unequivocally show, residential housing is the costliest land use type to a town than any other land use type. In general, tax revenues generated by housing aren't sufficient to support it. On the other hand, other types of development (or simply leaving land undeveloped), cost a town 25 cents or less on the dollar. The simple reason is, compared to any other sector, residential development relies on a massive amount of town services to support it. PA 490 concludes "it is in the public interest to encourage the preservation of farm, forest, and open space land."

Apart from taxes, and arguably more important to consider, is the character of a town & its quality of life. Much of this comes from good town planning, envisioning what a town will look like decades from now. The Plan of Conservation & Development (POCD) is a state required doc that does just that. The POCD forces a town to set a minimum of 10-year goals to strive toward. Towns update their POCD's every 10 years. They evaluate the success of past goals, and accordingly set new goals for the next 10 years. The first focus listed in our current POCD is to "Preserve and Protect the Town's Agricultural Lands and Rural Character." Sounds a bit similar to PA 490, doesn't it?

My message here is simple. Everyone who has a hand in shaping our town and its future should look to PA 490 and NB's current POCD for guidance - before they commit to a path forward. The decisions made today by our leaders will affect the health and prosperity of our community for many years to come. They should be well thought out and as informed as possible. If not, the outcome might not be what they expected.


