

I believe the Fire commission report was written under a false assumption, and semantics matter! The premise that P&X called upon Chief Seward to seek his professional advice at the May meeting is incorrect, and it is what has so many citizens up in arms. Citizens have not been accorded the same chance to speak that the Mayor, Councilman Don Fucci, who owns the property and not identifying himself as owner, and Chief all spoke at non-public hearings.

J.J. Sullivan, their lawyer and engineer, were presenting information to the commission, when these individuals spoke (non-public hearing), and expressed their support for what became the change in bulk storage of propane regulation. Then they wrote our regulation to suit their need, and never restricted the amount of bulk or what constitutes bulk.

In June, EDC, TC, and P&Z met to discuss the Charrette, and when bulk storage was brought up for discussion, it was denied as only the Charrette. But, the November 1st Charrette opened with "we want the towns peoples input", and this is what We concerned citizens wanted and needed to talk about.

Semantics matter: The Fire Chief thought he was being called a liar, because some differed with his opinion--not that anyone called him a liar as reported. He has done an amazing job with the volunteers. No one disputes that. Our issues are with a differing of opinion or another take on the propane safety and property value and revenue from this business.

Those who are being harassed, as documented by police reports, are those opposed to the bulk propane, not those that support it.

State Representative Vincent Candelora When It Rains, It Pours



I'd like to start out by thanking everyone for giving me the opportunity to represent you for another two years in Hartford. The beginning of a new session always brings a level of enthusiasm, but I am quickly grounded by the fiscal condition of Connecticut's budget. This next session is going to be more difficult than ever.

Throughout the election cycle, we heard optimism about the future and Governor Malloy predicted that our budget would end in a surplus. He continued to assure us that the budget policies would pay off in the future and that Connecticut is turning the corner. While he may still hold that belief, the numbers are painting a different story. Two weeks after the election, the state faces a projected deficit of \$100 million, and the state has run out of operating cash again.

The media seems to focus on the \$100 million deficit, but we cannot gloss over the fact that Connecticut is running a negative cash balance-something that hasn't occurred in almost two years. In my opinion, this occurrence is more dire than others because in previous years when Connecticut has run out of cash, it had a zero budget reserve ("rainy day") balance and deficits in the billions. Today, Connecticut has approximately \$500 million in its budget reserve. Additionally, in October, 2013, pursuant to the Governor's proposal, the state borrowed an additional \$598 million and added it to our cash balance under the guise of GAAP accounting. The state, therefore, had a cushion of \$1 billion in its checkbook. Normally, this cushion is sufficient to get us through the lean months, like November, without borrowing bond funds to operate government. So the fact that the state ran out of money caught all of us by surprise. If money is leaving the checkbook faster than its coming in, we must take a better look at our expenditures.

No one denies that we are in difficult economic times. I differ with the Governor on how we should handle these budget shortfalls, and I think even his administration now realizes that tax increases and more borrowing is not a viable option. His own budget chief acknowledges that Connecticut is in a "permanent fiscal crisis". I am hopeful that we will work together on a budget that solves our short-term problems, as well as our long term deficiencies. Connecticut can emerge from this recession more quickly if consumer confidence increases, and I believe that can only happen with bipartisan solutions to our budget woes.

PLANNING FOR THE FUTURE

Clients often ask me if they should discuss their estate plans with their adult or nearly adult children. As long as your kids are not anxiously waiting for you to die or actively planning your demise, there are many benefits to discussing your plans with your children. Talking about your estate plan with your children can eliminate surprises after you die. A quick conversation can ensure family harmony long after you are gone. When your family gets together this holiday you should consider starting a discussion about your estate plan. Whether you have a plan in place or are considering putting an estate plan into place, family get-togethers provide the perfect opportunity for such discussions.

Communication is the key. When speaking with your children, explain the who, what, when, where, how and WHY of your estate plan. This makes it easier for your children, as well as the planning professionals who may be left with the task of explaining what you were trying to accomplish through your estate plan. Some children may feel slighted because they were not named as Executor or Trustee. If you are concerned about one of your kids feeling this way, I suggest getting out in front of this problem. There may be very good reasons for why that child was not named. Look for opportunities to communicate the reasons why.

Often, children will regard unequal treatment in an estate plan as a statement of their parents love or lack thereof. This, of course, is usually far from the truth. Sometimes parents wish to provide more for a child who needs more help, and less to children who are more successful. It is imperative that you communicate your reasoning with your children. If there is no communication, it is often left up to the often vivid imagination of the child.

A decent estate planning attorney will always help you plan for dollars and cents. A good estate planning attorney also takes into account the family issues and dynamics. For many people, preserving the family unit after you are gone is a major concern. There are things that you can do today, that will have an impact on the lives of your children long after you pass. We often invite our clients to bring their children in. It is always nice to meet the people who will benefit from the planning that we do. Children can

State Senator Ed Meyer For a Leaner, Better State Legislature

I want to share with you some legislative reform bills I introduced during my decade as your state senator, which did not pass and generally were not even taken up by a committee. Connecticut is the fourth smallest state in the United States with a total population of about 3.5 million, and yet we have two separate houses of the legislature, comprising 187 state legislators. Several years ago, I visited Nebraska to look at its unicameral (one-house) legislature and was amazed at its efficiency and effectiveness. Thereafter, I introduced a unicameral legislative bill, but it got no public



hearing. I could well envision in Hartford a one-house legislature with 60 state legislators each serving about 50,000 residents.

Many state legislators in Connecticut, as well as other states, serve for twenty and more years. With exceptions, that longevity results in a loss of energy and a vacuum of new ideas. For some years, I have proposed term limits whereby state senators would serve three terms of four years each, and state representatives would serve six terms of two years each. Again, that bill has never received a hearing.

Connecticut, like many states lacks healthy competition in many of its state legislative campaigns. The great majority of legislative districts are one-party districts, primarily the Democrats in the metropolitan areas and the Republicans in parts of Fairfield country and in the more rural areas. Re-districting intentionally avoids combining part of a metropolitan area with part of a rural area as one district. In over one-third of our legislative districts, the incumbent legislator has no opponent or no major party opponent. The reason for our redistricting plans is that they are totally controlled by the legislative leaders of the two parties whose primary goal is to bring back incumbents every two years. Competition would be built instead by creating an independent redistricting commission without legislative or political leaders. Again, my bill to do that has not received any hearing.

There have been ethics problems in the Connecticut General Assembly, and indeed in the last several years three of my Senate colleagues have been convicted of crimes and have involuntarily been ousted from the Senate. The legislatures of other states, as well as Congress, have enacted Codes of Ethics and Ethics Committees to enforce that Code. I have introduced such a bill in each of the last ten years. In a couple of those years, the bill did clear committee, but was not taken up on the floor of either the Senate or the House.

As a result of my retirement, I urge you to press for some or all of these bills which, from my experience, will produce a leaner and better state legislature. Go for it!

be involved in the process by discussing Executor and Trustee selections with you. This gets them involved and makes them feel like their opinion has worth, which will reap dividends for many years to come. 



Carbon Monoxide, What you need to know:

Carbon monoxide (CO) is an odorless, colorless gas that interferes with the delivery of oxygen in the blood to the rest of the body. It is produced by incomplete combustion of fuels that include coal, wood, charcoal, natural gas, propane, and fuel oil. Problems can arise as a result of improper installation, maintenance, or inadequate venation. The symptoms are sometimes confused with the flu or food poisoning. Infants, elderly, pregnant women, and people with heart or respiratory illness are particularly at high risk from the effects of carbon monoxide poisoning. Nationally an estimated 300 people a year die as a result of carbon monoxide poisoning and thousands of others end up in the emergency room.

What you need to do: Ensure that all fuel burning appliances are properly adjusted and maintained. Have annual inspections of heating systems, chimney and flues. Never leave a car running in the garage. Install a carbon monoxide detector near your sleeping area.

If your CO detector goes off, or if everyone in the house are experience flue like symptoms that improve when your not home, call 911 and get out of the house.

Fireplace and Home Fire Safety:

With the high price of fuel oil and natural gas, many homeowners are using alternate heating sources. Last year, North Branford Fire Department responded to numerous chimney fires, and furnace malfunctions.

More than one-third of Americans use fireplaces, wood stoves, and other fuel-fired appliances to heat their homes. Unfortunately, many people are unaware of the fire risks associated with wood and other fuels.

North Branford Fire Department encourages you to practice the following fire safety steps:

- 1. Have your chimney or wood stove cleaned and inspected annually
- 2. Keep the area around your fireplace or stove clear of flammable decorations or materials
- 3. Always use a metal mesh screen with fireplaces, and keep your glass doors open
- 4. Never use flammable liquids to start a fire
- 5. Use only seasoned hardwood
- 6. Build small fires that burn completely and produce less smoke
- 7. Never burn cardboard, trash or other debris in your fireplace or wood stove
- 8. Never leave a fire unattended and extinguish before going to bed or leaving the house
- 9. Soak hot ashes in water and place them in a *metal container outside and away* from your house
- 10. Cover the chimney with a mesh screen spark arrester
- Install smoke alarms and carbon monoxide detectors on every level of your home
- 12. Have your oil or gas furnace serviced at least once a year
- 13. Provide proper venting for all heating appliances

Don't Forget Your Appliances

Dryers: The leading cause of dryer fires is a lack of maintenance. Whether you have electric or gas these simple rules can prevent a tragedy.

- Do not operate dryer without a lint filter. Clean filter before and after each
- Clean out the exhaust duct at least once a month.
- Once a year, remove the back cover and vacuum out the area around the heating element.
- Use only metal flexible pipe and the shortage distance possible to the outside.
- Make sure that the dryer is plugged into an outlet suitable for its needs. **Do not use extension cords**.

Ovens: Cooking fires are the number one cause of home fires and injuries. Unattended cooking is the leading cause of kitchen fires.

- Keep cooking area clean and clear of combustibles.
- Do not wear loose fitting cloths that can dangle onto stove burners and catch fire.
- Follow manufactures instructions on self-cleaning ovens. Clean heavy accumulations of grease before starting cleaning cycle.
- If a fire starts in the oven, turn off electric power or gas supply, do not open door.
- If a small fire starts in a pan on the stove, turn off electric power or gas supply
 and cover with a lid. Do not remove lid even if the fire appears to be out. Do
 not use water to extinguish a grease or oil fire.
- If you have a Microwave Oven fire, keep the door closed and turn off the power.
