# Planned Development Snubs Town's Plans for Open Space CorridorDear Editor;Most of the area currently designated for open

The open spaces in North Branford–the rivers, lakes, fields, farms and woodlands–are what make our town so special. It's why a lot of young people decide to settle here and raise a family. However, open space is slowly disappearing as builders buy up large tracts of land for housing and commercial development. Finding a healthy balance between development and the need to protect the scenic beauty and natural integrity of our area is more important than ever.

For this reason, I am particularly concerned about the development proposal for 363 Totoket Road. If the town's vision is to have an Open Space Corridor around the Farm River for public enjoyment, the current proposed configuration of a new subdivision does not support this goal. There is little allowance for usable land for open space between the subdivision and the Farm River. space on the plans is composed of wetlands and watercourses, which are not viable for public recreational use. Having a subdivision so close to wetlands that has a history of flooding would endanger the organisms and wildlife that the river supports. Changes in landscape, such as developing tracts of land, can introduce pollutants, including road salt and fertilizers, that can interrupt stream and pond habitats and affect the quality of the water that we drink. Also missing from the plans is a way to safely remove dumped garbage and wood chips from the proposed site without impacting the environment, and the restoration of the riverbed and riverbank. I feel that this is a major oversight. The Town should consider carefully before approving development in such a sensitive environment.

#### State Representative Vincent Candelora **Special Transportation Fund: Its Time for A Plan**



Many of us were caught off guard when Governor Malloy announced a freeze to all transportation projects. Malloy outlined nearly 400 projects worth \$4.3 billion that would be suspended over the next five years because of inadequate funding for transportation. The legislature is left to solve this dilemma, and we are quickly hearing about

tolls, gasoline taxes and millage taxes.

I'm open for the discussion, but I think a conversation about revenue is premature and misleading. For instance, the majority of people are in favor of tolls, but I wonder if residents realize that the proposal requires tolls on all interstates throughout Connecticut, not just on the border, and would cost travelers approximately 20 cents per mile. The average family in Connecticut would be paying over \$1200 annually to travel through the state. To avoid the tolls, traffic on Route 1, Route 5 and Route 17 would only increase. In the long run, tolls may still be appropriate, but the state needs to provide a fully vetted plan before I would ever consider even voting for them.

I believe the legislature needs to discuss and implement a transportation plan before we figure out how to pay for it. Governor Malloy has more than tripled annual transportation spending. Under both Governors Rell and Roland transportation spending averaged approximately \$250 million per year with debt service payments ranging around \$400 million annually. Under Governor Malloy, annual spending increased to almost \$600 million annually with debt service increasing to \$490 million annually. In times of deficits and decreasing gas tax revenue, the Governor increased spending throughout his tenure and failed to produce any comprehensive transportation plan. Now we are in crisis.

For two budget cycles, Republicans have proposed a transportation spending plan that is balanced without any new taxes. Unfortunately, the plan failed to become law, but Democrats are committed to work together this session to provide a solution. I believe that it is time to implement a transportation authority that would make long-term recommendations on infrastructure investment. Despite the heavy congestion in Fairfield County and the difficulty in traveling expeditiously to New York from New Haven, the state focused on a busway in New Britain and high-speed rail from Wallingford to Springfield, MA. Ironically, as our casinos in eastern Connecticut fight to remain competitive against the MGM casino, Connecticut is spending hundreds of millions



of dollars to send our residents to the MGM casino on convenient high-speed rail, hardly a good investment!

I believe we will fix transportation funding this session; however, the debate needs to begin with a spending plan and long-term planning, not with a debate on tolls or gas taxes. I will not support any proposals for new revenue until we have a mechanism in place to spend it wisely.

# All Along the Watchtower

Isaiah 21:6 - "Go, set a watchman, let him declare what he seeth." Dylan wrote of him and Hendrix covered it with profundity.

The "Office of Inspector General" (OIG) is that part of government that investigates the investigators, the folks who keep law enforcers in line by investigating and revealing the illegal or corrupt doings of those who would otherwise wield evil power over us. Our federal government's OIG was principally founded by laws written in 1978 in the aftermath of the abuses of the Nixon administration.

There are actually 73 separate inspectors general, each specific to a federal agency, but a single chairman oversees them all while also serving as the inspector general of our Justice Department. Since 2012 that man has been Michael E. Horowitz.

Horowitz is an Obama appointee, but he battled the Obama administration for 4 years over his right and ability to access DOJ records. Simply put, the Obama administration refused to give Horowitz the unfettered access to Executive branch records in accordance with what had been the law since 1978. My review of his war with the Obama administration reveals that he has focused on two important areas: (i) gun running and; (ii) wiretapping. The Obama administration's secrecy becomes all the more interesting in light of the breadcrumbs leading from the Holder era's DOJ to the current state of affairs. (pun intended) Recent reports strongly suggest that Horowitz is aiming to bring to justice those in our federal government who have been illegally running guns - not to Mexican gangs - but through Mexico to Hamas. In addition, the OIG may be taking aim at illegal surveillance conducted by our FBI. Horowitz is tasked with being our watchman. We should hope and pray that he is resolute in an unbiased quest to follow any trail of corruption to its logical end, no matter who or how powerful any sinister figure might be at the end of that trail. Once our watchman declares what he has seen we cannot turn a blind eye to it. It is our duty to keep eyes open, discern the right from the wrong and hold accountable those who would otherwise do wrong to our brothers and sisters. © D. North Branford Fire Department continues to provide the highest quality of emergency and non-emergency life safety services to the citizens and visitors in our community. Through the department's commitment to continuous improvement, staff development and implementing new and innovative programs to create greater economic efficiencies and improve emergency service effectiveness to North Branford residents. In compliance with National Fire Protection Standards (NFPA) 1720, Standards for the Organization and Deployment of Fire Suppression Operations, Emergency Medical Operations and Special Operations to the Public by Volunteer Fire Departments, the North Branford Fire Department exceeds the national consensus standard, on scene within 8 minutes after dispatch.

During 2017 North Branford fire department personnel answered 1840 calls for service. The dollar loss related to fire damaged property during this period was \$596,500. Property saved was in excess of 24 million dollars.

### PLANNING FOR THE FUTURE II By Attorney Marc P. Guertin

Many of my clients have what I would call an "If I die" attitude (at least in the beginning of our relationship). They plan or don't plan based on the fact that they "might" die (that's where the "if" comes in). The conversation typically goes something like this: "Well, if I die I would like my house to go to my daughter." I chuckle a little bit and usually say something like, "If you die... Oh, you are going to die!!"

In a way we are no different than a carton of milk in that we all have an "expiration date." Ironically, many people plan more for the expiring carton of milk than for their own expiration date. I have a few clients who honestly believe they are not going to die at all. They seem to be quite rational in all other ways but on the question of death they are swimming in denial. My question to them usually is "If you are immortal, why have you chosen New Haven county to live... forever?"

Death should not be dealt with as a distant abstract possibility, a dark horse candidate or a long shot. Your estate plan should reflect what happens **when** you die, not **if** you die.

So... what happens if you like swimming in denial and you don't make a plan? Fear not, the State of Connecticut has a plan for you. Because you left no direction, the State's intestacy laws will dictate where your assets go; and your assets may not go to who you think they would.

Assuming that you do not want the State of Connecticut to do the planning for you, a properly drafted Last Will and Testament or a Trust will ensure that your final wishes (regarding what happens to all of your *stuff*) are honored. It is important to acknowledge that you have a finite amount of time in this world and to plan accordingly.

A well-crafted estate plan contemplates more than you dying. It also contemplates what happens if you don't die and are just incapacitated. In the absence of a plan, it becomes very costly and time consuming to gain the legal power to help someone who is incapacitated. However, a wellprepared estate plan plans for these events, which makes it easier and more cost affective for all

### Former Town Manager Publishes Novel on Local Government



Frank Connolly, North Branford's former town manager, has just published a novel on local government. He served as North Branford's Town Manager (1991-2001), and as its Community Development Action Plan Coordinator (CDAP 1968-1970). His career also included serving as Town Manager of Newington and Coventry. He was Coventry's first Town Planner when that Town faced a proposal to build a massive "New Town" within its borders in the 1970s.

His novel, *Hidden Agenda: Inside Town Hall*, reveals just how tangled and involved small-town politics can become. It follows the volatile trail of a proposed land use development in the fictional Connecticut Town of Covingford. The novel touches on the roles of numerous boards as well as town staff.

The novel opens with a heated town meeting as residents rise up against the developers who are proposing a new shopping center on vacant land, adjacent to their established residential neighborhood. As a result of the proposal, the citizens of Covingford become split into bitter factions and experience a crash course on the murky world of local politics.

Out-of-town developers quickly get a taste of local government in the small town of Covingford. They know they need approval of the local planning and zoning commission and the support of local politicians. They underestimate however, the force of an aroused and angry neighborhood, and a little old lady who attends every meeting. On the surface, the proposed development sounds like a simple straightforward matter. Not everyone in Covingford embraces the new shopping center. The proposal quickly turns out to be anything but, starting with a rip-roaring New England town meeting where many angry residents are not afraid to express their feelings.

To help grease the skids to ensure local approval, the developer makes agreements with local politicians, hires a prominent local lawyer, and brings in an nefarious enforcer to put pressure on Dom "the Bomb" Columbo, head of the town's political committee. The "Bomb" is expected to exert his influence to assure the center receives approval. He soon discovers that influence is a double-edged sword. Louie the "Enforcer" suddenly appears on the scene to make it ominously clear to Dom that the proposal had better get approval, since Louie's employer "pays for results, but also pays for no results".

Tension builds. Janet Johnson, local news reporter, provides keen insight into the many political shenanigans as she shines light on several hidden agendas. As this inquisitive local reporter digs, her articles raise questions on the vacant land, adding fuel to the enraged neighbors. Letters to the editor further accelerate the charged atmosphere as Covingford becomes a battleground. Everyone has a side, and every side has its own hidden agenda. The stakes rise, and drastic maneuvers are undertaken. The surprise ending stuns everyone.

Mr. Connolly has written several articles on local government and is an adjunct faculty member in the Public Administration program at the University of New Haven. He is also the author of the textbook *Local Government in Connecticut*, currently in its 3<sup>rd</sup> Edition. This book won the 2013 Wesleyan University Press Driftless Award for an outstanding book in any field on a Connecticut topic or written by a Connecticut author.
