"Knox Box" Ordinance Requirements

On March 1, 2018 North Branford Town Council enacted Ordinance #252, which amends Chapter 40 of the Code of the Town of North Branford. The following is a summary of the new ordinance. A copy of the entire ordinance, Chapter 40 is available in the Town Clerk's Office or on the town website.

All Commercial occupancies are required to install key lock boxes, containing keys to their premises

Multi-family residential structures that have restricted access and have a common corridor for access to the living units are required to have a key box.

These boxes will allow for rapid entry without the need to cause excessive damage to doors and windows in the event of an activated fire alarm or incident during non-occupied hours.

Affected property owners have 6 months to comply. Failure to comply will result in penalty of \$100 per month.

In life, Aunt Mary Mentone was the most generous person I knew. As the innocence of youth faded into the cynicism/realism of adulthood, I started to realize it was generosity to a fault. She would figuratively give the shirt off her back to someone she loved, especially her parents, brothers, nieces, and nephews.

In death, Aunt Mary (with an assist from uncle Frank) was able to once again make life just a little bit easier for her three nephews and two nieces. But that's not why I will never forget her.

Her funeral last summer was a bittersweet day. While sad that she was gone, I took a little measure of happiness in finding out from my uncle's eulogy that my birth may have changed her life. She apparently went from someone struggling to find herself to someone with an identity that would last the rest of her days - she became Aunt Mary. 



State Representative Vincent Candelora **Dual Arrest Policy in Connecticut Domestic Violence Laws**



Domestic violence is a complex aspect of life that involves a lot of grey – so to speak. Not only is this matter difficult for all parties involved, but it has proven to also be difficult for law enforcement. This legislative session I co-sponsored a bill that would eliminate Connecticut's dual arrest policy. About three years ago, a law enforcement constituent of mine approached with the idea for this proposal in an effort to protect victims of abuse. I have raised

this concern every year since. Connecticut needs to change its existing intimate partner violence dual arrest law to add a 'dominant aggressive' provision.

Current statistics show that Connecticut has a 20 percent dual arrest rate, which means that 20 percent of the time law enforcement arrests both aggressor and victim in a domestic violence incident after police intervention and investigation. These statistics are alarming because Connecticut's dual arrest rate is double national rates.

The intent of Connecticut's mandatory dual arrest policy was to remove discretion at the incident scene. However, the reality is that this law was followed by many unintended consequences—victims were being arrested too. As you can imagine, the arrest of a domestic violence victim can have detrimental effects as these individuals are struggling to find a way out of the abuse. To say the least, victims of domestic violence have experienced first-hand the unintended consequences of dual arrest when they make the call to have police intervene—small children who just witnessed a parent being abused are traumatized when both parents are carted away in police cars, public reporting of the arrest result in 'quiet' gossip among neighbors, and many feeling victimized all over again.


Due to the ubiquitous nature of the Internet, victims of abuse now have access to information and services at the tips of their fingertips, and can access these services anonymously without the fear of calling the police, and what repercussion doing so may entail.

It is evident that this law is now antiquated, and is consequently doing more harm than good. As time has passed and we as a society have evolved, we've have found that there are many complications and issues surrounding the dual arrest policy.

If the current law pertaining to dual arrest changes, I do believe that law enforcement would benefit from training that would assist them in properly evaluating who the aggressor is in order to make an arrest. We need to ensure that our officers have the skills needed to conduct their job effectively. Right now they are caught between a rock and a hard place when it comes to addressing domestic violence cases. I certainly understand the concern expressed by some law enforcement around the liability that can come when an arrest is not made, especially when our statutory language dictates an arrest in response to an incident of family violence. These are emotionally charged situations; however, asking the state to allow police officers some discretion in handling the incident by adding a 'dominant aggressive' provision will help reduce the harmful impact on victims and their families.'

This call to change Connecticut's family violence arrest law aims to clarify complexities associated with current law. When receiving complaints

The Lone Gunmen

The Parkland Florida school murder story: Cruz arrived in an Uber car at 2:19 p.m., was inside shooting 1 minute later, ran from the school after only 9 minutes, shot 2 people outside as he ran "towards the tennis courts, turned south, crossed fields and ran west, trying to blend with the students" and an hour later was identified and arrested at McDonald's based on a description of his clothing. This quote, from Sheriff Israel to the Washington Post the day after the shooting, indicted Cruz as the lone gunman before any investigation or review of surveillance video. The Sheriff's narrative remains virtually unchanged despite conflicting evewitness accounts.

"I suddenly saw the shooter about twenty feet in front of me standing at the end of the hallway actively shooting... just a barrage of bullets, and I'm staring at him thinking why are the police here, this is strange because he's in full metal garb, helmet, face mask, bulletproof armor, shooting this rifle that I've never seen before." This account, to ABC news from teacher Stacy Lippel, describes the events in her 1st floor hallway. Teacher-eyewitness Earnest Rospierski also saw an unidentifiable, masked gunman shooting students in his 3rd floor hallway.

"Alexa," a Parkland student interviewed immediately after the shooting by KHOU-11 television (covering Astros spring training) said she walked and spoke with Cruz while being evacuated in the school hallway. She had known him as a troubled student for years but wasn't afraid because he was unarmed and gunshots were being fired elsewhere. In a KPRC channel 2 news interview another student definitively described simultaneous shooting in 3 different parts of the school.

Corporate News and law enforcement seem to ignore these eyewitness accounts. None has asked how and when Cruz could have put on, taken off or disposed of the tactical gear described by Lippel as he riddled three floors with bullets in 9 minutes. None have questioned how Cruz's semi-automatic AR-15 (pop, pop, pop) transformed into the unrecognizable fully automatic rifle Lippel described spraying a "barrage of bullets." All avoid mentioning that any shooter wore a helmet, mask or body armor or that any such things were recovered at the scene. How did the police arrest Cruz based on his clothing if he was this masked, military-clad mystery man? Did ANYone see Cruz with a gun? How did Cruz shoot 2 people outside while managing to mingle with students? No one seems to have followed up on the multiple shooter lead.

The fact that 17 people were killed in cold blood in another gun free zone should trigger a profound desire to thoroughly investigate and solve these riddles. Instead, within minutes of the murders, the public eye focused solely on a single subject, a myopic, tired story of a mentally unstable, lone gunman that forecloses real investigation. While reality may converge on Cruz, 55 years of this lone-gunman narrative brings this quote to mind: "Power concedes nothing without a demand... Find out just what any people will quietly submit to and you have found the exact measure of injustice and wrong which will be imposed upon them. (Frederick Douglas)






