

The Trust Act, Anything, but . . .



In 2013, Republicans and Democrats unanimously supported the implantation of the Trust Act, which created guidelines for how police handled arrests of illegal immigrants who were subject to federal civil detainers. The law was established to create trust between local law enforcement officials and illegal immigrants so people

in that community would be more willing to come forward without fear of deportation to report crimes or cooperate with police. The law struck a balance between when to turn over illegal immigrants, namely certain people who pose a risk to public safety, to Immigration and Customs Enforcement ("ICE").

Unfortunately, the Democrats have repealed this bipartisan act and now significantly restrict local law enforcement's ability to hold a criminal illegal immigrant or even communicate with ICE. Criminal illegal immigrants who have the following charges cannot be detained for ICE and are shielded from deportation: a C and/or D felony charge or conviction; pending criminal charges in the state where bond has not been posted; an outstanding arrest warrant in this state; identified as a known gang member in federal database; subject to a final deportation order; or who local police views as an unacceptable risk to public safety. After many hours of debate, Republicans successfully negotiated a change to the law that would allow local police to contact ICE if an illegal immigrant has been convicted of a Class A or B felony, such as murder or rape, or is on the federal terrorist watch list.

I cannot comprehend why the Democrats felt the need to restrict law enforcement's ability to communicate with ICE and elevate the protection of criminal immigrants over the public safety of all residents. That federal agency has been over-politicized, and politicians fail to recognize the positive things they do to keep us safe. When the bill passed, advocates chanted in the hallways that illegal immigrants are protected from deportation. I disagree. Illegal immigrants are still subject to deportation under federal law. This law now merely prevents illegal immigrants who are sexual predators, gang members or public safety risks from being detained by local law enforcement. I guess elections have consequences, and this one may result in someone's murder or rape.

Let's Be "Frank"

Well brother, it appears that politics once again is showing its ugly head in our little town. I have been told that at our last Parks and Recreation Commission meeting, commissioners Brian Lynch and Victor Palma resigned. Shortly after that, Supervisor Lauren Munro handed in her resignation.

These two men survived the politics, and represented our town and community, always putting the citizens first.

As for Lauren, I have worked with her both on the commission and in other town events. She is top notch. PLANNING FOR THE FUTURE

Most people never think that they will ever end up in a Nursing Home. However, the sad reality is that almost half of the population will spend some time in a skilled nursing facility during their lifetime. According to the Centers for Disease Control, the average time spent in a nursing home is 864 days, nearly two and half years.

A long term stay at a nursing home can be financially devastating for you and your family. Nursing home care rates of \$15,000 per month can quickly eliminate a lifetime's worth of hard work. Long term care in a nursing home can devour your savings and force your home, business and other assets to be sold at a "fire sale" price to pay for your care.

After the passage of enough time the assets held by the IAPT will be insulated from the ravages of a long term stay in a nursing home, as well as creditor issues, and lawsuits. Furthermore, the assets held inside of the trust will pass to your beneficiaries' probate free and within weeks, as opposed to months if these assets were to pass to your heirs through the probate process.

Improbable Cause

"If we had confidence that the president clearly did not commit a crime, we would have said so," said Special Counsel Robert Mueller to the press on Wednesday, May 29, 2019. This is perhaps the most idiotic statement a lawyer of his stature could make, both legally and as a matter of common sense.

Common sense dictates that, if anyone has evidence that I didn't commit a crime, they should say something (e.g., someone was shot yesterday in Northford, but you were with me in Sweden at the time). But since you don't have direct evidence of all the crimes I haven't committed, you keep your mouth shut, most particularly if what you say suggests I committed a crime when you don't have good reason to believe I did. Since Mueller doesn't know about any specific crime I did or didn't commit, his mouth should stay shut. In this light, Mueller's comment strikes a blow to the otherwise well established doctrines of the presumption of innocence and probable cause.

In *Coffin v. United States*, 156 U.S. 432 (1895), our Supreme Court held that every man is presumed to be innocent until his guilt is proved beyond a reasonable doubt. This is also recognized by the UN as an international human right under Article 11 of the Universal Declaration of Human Rights. Our laws also require probable cause before a search or arrest warrant can issue and before a grand jury can indict. These principles prevent the government from using its powers to target us, invade our person, home and privacy, or persecute us with baseless accusations.

Mueller knows that each crime has specific elements and there must be probable cause for each before there is probable cause that the crime was committed. Absent any single element, there is no crime. Hillary Clinton, for instance, was effectively exonerated for her mishandling of classified documents when Comey said the element of "intent" was missing (albeit none was required). As to Trump, Mueller's team failed to find probable cause for the elements of "obstruction," and said so in part two of its report.

Mueller's comment effectively turns the presumption of innocence on its head and eliminates the need for probable cause. Unlike the special prosecutor's findings against Bill Clinton (5 counts of perjury, 4 counts of obstruction, 1 count of witness tampering and 1 count of abuse of Constitutional power) Mueller's team found no probable cause for obstruction. It doesn't matter that Mueller couldn't indict the sitting president because there was no probable cause for the underlying elements of obstruction. Mueller's legally inexplicable, irrational comment stands as a pointedly biased, unconstitutional assumption of guilt that falsely manufactures a basis to initiate further proceedings without probable cause.





“Reference the actual source materials”

To the Editor:

Despite his claims to the contrary, week after week, the column Kirt Westfall proffers, is less a dialog than a screed, based on misinformation gathered from the likes of Rush Limbaugh, climate denier websites, and purveyors of fake science. Mr. Westfall regurgitates misinformation that tries to look legitimate by using isolated data points, cherry picked from actual research, incomplete and out of context.

I looked up the Danish Meteorological Institute data and the reporting provided by Mr. Westfall is demonstrably false, as shown in all the graphed calculations over time, which use many systems of satellite and earth based data collection. I agree, the Danish Meteorological Institute is an excellent source. One just needs to quote data accurately and not rely on a discredited blog, published by a climate denier. And by the way, the actual data do not refute NASA’s data.

An excellent explanation of the actual graphing of sea ice by DMI can be found on YouTube, <https://www.youtube.com/watch?v=IMfjbBNSU2g> - or you can go directly to the DMI website and view the data and analysis yourselves, which is always a good idea.

Mr. Westfall’s commentary on forest fires is almost too ridiculous to refute. A reduction in acreage consumed by fire compared to length of fire season is like comparing oranges and dinosaurs. Eastern Coyotes:

The Wild North American Canine

On Wednesday, June 19, NBLCT is sponsoring a presentation by Paul Colburn, *Eastern Coyotes in Connecticut*, from 6:00 to 7:30 pm at the Stanley T. Williams Community Center, 1332 Middletown Ave, Northford.

In the last century, the eastern coyote has colonized the forests of eastern North America, from Florida to Labrador. Genetic tests show that Eastern Coyotes are actually a mix of three species: coyote, wolf and dog. The percentages vary, dependent upon the test and the geographic location of the canine.

Colburn will talk about their genetic characteristics and the natural history of the Eastern Coyote in Connecticut, including an overview of their habitat, diet, behavior, reproduction, and current research efforts. He will also share Eastern Coyote artifacts with the audience and practical recommendations for optimum coexistence with the Eastern Coyote population.

Colburn is a graduate of the Master Wildlife Conservationist Program (MWCP) and a certified Master Wildlife Conservationist (MWC). He has given over 150 wildlife presentations in Connecticut and participated in several wildlife research projects. An avid outdoors man, Mr. Colburn is a graduate of Wesleyan University and a US Army veteran.


