
### Rep. Candelora Achieves 100% Voting Record

Legislator Maintains Perfect Roll Call Voting Record for 2016 Session

HARTFORD — Deputy Republican Leader Vincent Candelora (R-86) this year achieved a perfect record during the 2016 legislative session.

Candelora, was present and voted for all 313 votes taken on the state House floor during the 2016 session, according to voting record data released today by the House Clerk's Office. Perfect attendance is very difficult to achieve, with only about 32% of legislators able to do so this year.





### Connecticut's Watchdog Agencies in Jeopardy

Ten years ago Connecticut created the "clean elections" program which created an independent branch in government to investigate election law violations. The Freedom of Information Commission, which is charged with making sure government complies with

open government and the State Ethics Commission, which addresses ethics violations, are in jeopardy along with our Elections Enforcement Commission. Beginning with his first budget in 2011, Governor Malloy has targeted these three agencies and has tried to eliminate their fiscal independence as watchdog agencies.

For the third time in six years, the Governor is again trying to make cuts to these agencies' budgets which will cripple their ability to do their job. When Democrats passed the budget, they gave the governor authority to cut \$68.8 million from the \$20 billion state budget. This authority allows the governor to make unilateral budget decisions, a measure that is unprecedented. As a result, he is free to effectively change policy and reprioritize spending without any approval. He again has chosen to target these agencies who have investigated his administration in the past for ethics and election violations.

The administration is cutting \$42,549 from the Office of State Ethics, \$44,442 from the Freedom of Information Commission, and \$96,032 from the State Elections Enforcement Commission. While these cuts don't produce much savings and seems like small numbers, the agencies have already endured significant cuts. They claim the cuts would violate a state law passed in 2004 in the last days of an ethically challenged administration to maintain the independence of the watchdogs and will cripple them from functioning.

The governor's proposed cuts raise eyebrows because his administration is in the middle of two high-profile cases. One involving the State Ethics Agency who is expected to rule on whether Insurance Commissioner Katharine L. Wade must recuse herself from the Anthem-Cigna merger and the second involves the Democratic Party fundraising improprieties in support of Malloy's re-election. The latter case is now under federal grand jury investigation.

It is curious that in order to save \$200,000 in a budget of \$20 billion, Governor Malloy opens himself up to serious criticism. Sadly, I believe it demonstrates how vindictive this governor is. He is willing to expend what political capital he has left in order to get even with agencies that have had to sanction his administration. Ultimately, I blame the Democrats in the legislature for this mess. They never should have handed over their budget authority for the governor to make unilateral decisions that changes Connecticut's policies and priorities. We are seeing the impacts to the state parks, now we are seeing the impacts to good government. What's next?

### PLANNING FOR THE FUTURE By Attorney Marc P. Guertin

A lot of my clients are very concerned with avoiding probate. Many people believe that as long as they have a valid Will, they can avoid Probate. This is exactly the opposite of what actually happens when you die with a Will

A Will is often called "a ticket to Probate." If you really want to avoid the time, expense and public nature of the Probate process, a Will always falls short of the mark.

Many people look to Revocable Living Trusts to avoid probate. Probate is the process of removing a decedents name from property and assets that person owned when they were alive. So, it follows that if your name is not on any property or assets when you die- there is no need for probate. Revocable Living Trusts help people to do just that.

A Revocable Living Trust acts as a legal container that holds property for the benefit of the beneficiary of the Trust, who is usually a person, an institution or a charity. Trusts are legal agreements between three different parties: The Grantor (sometimes called a Trustmaker or Settlor) who establishes the Trust, the Trustee who administrates the Trust, and the beneficiary, who receives some sort of benefit (usually income) from the Trust.

Imagine a Revocable Living Trust as an "open box." You can put assets into the box and you can take assets out of the box. You can manage the assets in the box or appoint someone else to do that for you. You have total control- just as you would if you owned the assets outright (outside of the trust). Assets owned by the Trust (most likely managed by you for your benefit) will not have to be probated when you die-because you don't own them- the Trust does.

Revocable Living Trusts are a great method of avoiding probate and the costs, lack of privacy and time associated with probating an estate. By using a Revocable Living Trust you can put your assets into your beneficiary's hands in days instead of months, minimize the cost of transferring the assets, and do so privately.

### WIT & WISDOM

The recent threatened invasion of the gypsy moth that caused much concern and brought back memories of the miles of leafless trees in the 80ties, which brought back memories of my year in the 20ties and a similar devastation by the Tent Caterpillar. While probable most of you have seen an occasional Tent Caterpillar hanging in a tree an invasion of more than a few here and there are a rare occasion and raises no concern.

I remember as a child seeing an invasion of Tent Caterpillars. While not as completely devastating as the Gypsy Moth, but nearly so, they made a not to be forgotten, memories of seeing what seemed to be trees virtually covered with tents as one rode thru the countryside. Remember this was years before the age of pesticides and caused much concern as to the survival of our trees.

Those having commercial fruit growing operations, as did my parents, went through the trees gathering the tents on their first appearance and removed them into bags and burned them. The other trees were left to their fate, but someone came up with an idea that proved an amazing success. The eggs of the Tent Caterpillar were encapsulated in hard scabs, my best description, on the smaller limbs and easily recognized.

Someone came up with the idea of having the school children gather these egg clusters, bring them to school, where each child's harvest was counted and the one whose collection was the most fruitful was rewarded with some simple award. With every boy carrying a pocket knife it was a simple operation to scrape the cluster off or if need be, cut the sector of the branch involved. So fascinated were we all with this opportunity to help nature and save our trees it became more important to get out of school than studying and we couldn't wait for the dismissal bell. With every child wandering far and wide gathering their clusters it must have worked for the Tent Caterpillar infestation soon died and since has never been a concern. Of course the advent of insecticide and pesticide spraying had much to do with that.

How much more exciting was my one mile walk home, scanning each tree on the way, than today's children's cooped in a crowded school bus.

My recent articles on spraying with Potassium Carbonate {baking power} and fertilizing with Sea 90 minerals and bagging fruit in the Farm Show publication, probably the most widely circulated Farm Journal published in the hundreds of thousands, resulted in calls from as far away as Ontario, Canada, Illinois, Pennsylvania. Even a fellow in Bayside, Long Island wants to ride up to meet me. I told him he had better call first less my ashes are all he will see.

With Farm Show a misnomer, since there is information pertinent to every sector of our society, even you, I hope to do an article on it that will prove helpful to all of you.



One was of an 18u female player on Force (a New York based team) that had committed suicide while the other was of a traumatic brain injury sustained by a 14u female player of Team Nitro (another New York based team). It was undecided if Team Nitro 14u would attend the tournament in East

Hartford & play in her honor. The 18u Force team declined to attend the tourney & grieve privately. The staff, players & families all participated in purchasing bracelets that the USSSA provided to each team with both team logo's. The staff & players of the Shoreline Sting 14u Gold team decided to try to honor the 14u injured player by ordering custom made batting helmet stickers that had the injured players initials (RS) & her jersey number (44) on the stickers.

At our practice on Friday evening (7/15/2016), the staff revealed the batting stickers to the team and all members requested to wear the stickers honoring *Rhionnan Scott #44*, on their Sting batting helmets. They placed the stickers above the left side ear hole.

On Saturday 7/16/2016, in between the Shoreline Sting 14u Gold team games, the players sought out Team Nitro 14u who was preparing to play on a nearby field. The members of the team, along with a few Coaches, walked down to the dugout of Team Nitro 14u and spoke to them briefly passing on our best wishes for a speedy recovery of their teammate & friend. We then presented them with the batting helmet stickers, for them to wear, if they chose. Members of Team Nitro 14u appeared to be very touched, along with the Coaches & parents who were nearby. The Team then placed the batting helmet stickers on their helmets before their game.

In today's uncertain world, it was a pleasure to observe these young ladies of the Shoreline Sting 14u Gold Team display their heartfelt compassion and love that can make all parents proud! They all recognized that softball is a game and that this matter, involved a life. These young ladies rose and thought of others before themselves. As a parent & a Coach, I could not be more *PROUD* of this team than I was at that moment. Whether we won or lost that day, was not as important as how these ladies touched another set of young ladies dealing, personally, with a traumatic situation. We were all met with a reality that it could be *our* team or one of us dealing directly with this tragedy.

Unfortunately, we received word that Rhionnan Scott passed away early Sunday morning (7/17/2016). Our Team members were shocked by the news that we shared with them but were glad that we provided Team Nitro 14u with our thoughts & prayers the day before. We unfortunately, were not able to get together with Team Nitro 14u before they departed but, they know that we are praying for all of them & their families. May God bless Team Nitro 14u & their community as we hope that Peace finds them soon.


