

From the desk of Mayor Anthony Candelora Food Pantry - "A Marathon, Not a Sprint



During the last few months a group from Matt's Mission came to the Town Council asking to use the vacant senior center for a food bank. The Town Council listened to a very ambitious Lynn Riordan and Frank Forgione give a presentation. Matt's Mission is donating \$10,000 to start a non-profit organization – The North Branford Food Pantry.

Questions on a lease and how to pay for the utilities and maintenance of the building were discussed. A second meeting was held and a lease is currently being written and the Town Council asked for a floor plan and

a business plan, as well as a report from our Building Official, Fire Marshal, Park Rec Director, and Public Works Director. The Council supports this noble cause and wants to help and provide for our residents in need, but we need to make sure the correct process and procedures are followed because the building will still be owned by the Town.

Since that time, questions have arisen. We presently have two food banks, one on each end of town. We have the 211 Service Roof (which provides people free advice at times if they are unable to pay their mortgage). We also can provide breakfast and lunch through a state program provided through our school system should there be a need. The building will also be used by Friends of the Library to sell books to help support our libraries.

Having said all of this it came to my attention that a small group of people, through social media, have been making statements about this project that simply are not true. The facts are that over the last few years our town has been through many changes. We have closed a school, closed the old Community Center and Senior Center, and moved those programs to STW. We have not budgeted money to operate the former community and senior center buildings.

I want to emphasize there are about 16,000 residents in our town and we all want to help a neighbor or family in need which is why I and many other residents donate our time and/or money to many causes. When dealing with town buildings or a municipality, you have to follow the charter and town ordinances. I don't know too much about 501c3 other than what I have read. It doesn't matter that a 501c3 organization wants to operate on the premises, the Council still needs to follow protocol.

As an example, a new handicap ramp needs to be installed to meet all building codes, which includes being ADA compliant. Any project over \$7,500 MUST go out to bid. The Town can accept donated services but all the same protocols regarding insurance, permits, building codes, etc. have to be met.

As an example, we were approached about a town dog park. The group came forward provided their business plan and began raising money to build the park. This has gone on for three years. They still have the passion and they still want to build a park. They are going through the process step by step. I commend all these people that volunteer and want to help our town and our less fortunate.

Make no mistake, North Branford has always taken care of one another. That's what makes our town such a great place to live. A food bank is a great service to provide to our people. However, we need to make sure we are able to budget money to operate this building.

This raises questions about using taxpayers money for a 501c3. During budget time we are told increasing the budget will only increase a household \$50.00. Well this week I have gotten many calls that "my taxes went up \$800.00. I can't afford to live here anymore"!

So again I want to reiterate: Are we helping the masses or hurting them? I have been honored to be a volunteer Mayor. The Council and I try very hard to make the right decisions for our town. Who would not want to provide food and assistance for those in need? We just have to go through each step of the process and make sure we provide a program that will help many and not add cost to an already tight town budget that has no additional money available.

For those that do need assistance we do have Social Services, 211 Roof, The Night of Caring, The Community Food Drive, Fill the Cruiser, and many others. These services and directions for those in need are on the town web site: www.townofnorthbranfordct.com.

We will keep working on the The North Branford Food Pantry. We have to remember all things need to be done properly and we need to consider the needs of all our 16,000 residents when making these decisions. This is not a sprint but a marathon. Hopefully in the end the entire town will be standing at the finish line with a formidable solution.

Our next Town Council meeting is August 12th and we should have the additional information we requested to continue this project and keep moving it forward.

Legislator Maintains Perfect Roll Call Voting Record for 2014 Session

HARTFORD — State Rep. Vincent Candelora (R-86) this year continued his exemplary record of service to constituents by registering a 100 percent House roll call voting record during the 2014 legislative session.

Candelora, who represents the 86th District covering Durham, Guilford, North Branford and Wallingford, was present to cast every vote on the floor of the state's House of Representatives.

Serving the people of the 86th District is truly an honor," said Rep. Candelora who is the Legislature's Deputy Republican Leader. "I take my role here in the capitol very seriously, understanding that in order to serve my constituents effectively, I have to be both present and attentive at every roll call. PLANNING FOR THE FUTURE

Revocable Living Trusts serve many functions. One of the most useful functions of a revocable living trust is that if properly funded, it enables a person to avoid the probate and the time and expense that goes along with it.

At its core probate is the process of removing a decedents name from property and assets that person owned when they were alive. So, it follows that if your name is not on any property or assets when you die- there is no need for probate. Revocable Living Trusts help people to do just that.

A Trust acts as a legal container that holds property for the benefit of the beneficiary of the Trust, who is usually a person, an institution or a charity. Trusts are legal agreements between three different parties: The Grantor (sometimes called a Trustmaker or Settlor) who establishes the Trust, the Trustee who administrates the Trust, and the beneficiary, who receives some sort of benefit (usually income) from the Trust.

Imagine a Revocable Living Trust as an "open box." You can put assets into the box and you can take assets out of the box. The box is an alter ego for you. You can manage the assets in the box or appoint someone else to do that for you. You have total control-just as if you owned the assets outright (outside of the trust). Assets owned by the Trust (most likely managed by you for your benefit) will not have to be probated when you die-because you don't own them- the Trust does.


Revocable Living Trusts are a great method of avoiding probate and the costs, lack of privacy and time associated with probating an estate. By using a Revocable Living Trust you can put your assets into your beneficiary's hands in days instead of months, minimize the cost of transferring the as-



My Week Without Sarcasm by Lindsay Lee Wallace

On November 28th, 1997, at 8:59 AM, while my dad was yelling "Push!" and my mom was replying "No!" and dad was insisting "Push!" and mom was answering, "Yeah, okay, because that's how C-sections work!", I was waiting less-than-patiently to make my grand entrance. Before I'd even seen the world, I was making it a more difficult place by insisting on being upside down. It was only two months later, when I'd been squeezed like a sausage into a pink onesie to be professionally photographed in all my toothless glory that I began to rethink my earlier eagerness to enter the world. I don't know this because I remember feeling that way, but because of the photographs, which managed to capture my father as he placed a kiss on the top of my downy baby head, which I reacted to by staring away from him in exasperation. The message on my face is clear: "Oh gosh, who is this guy?" This particular photograph has since been framed, and is displayed proudly in the living room, where it stands as a testament to not only the nature of my relationship with my father, but to my relationship with the entire world.

Sarcasm has always come easily to me—too easily, some might say. Although amusing now, my photoshoot had my parents despairing at the time: my mother over her investment in a photography session that had yielded little adorable-ness, and my father with his conviction that after only eight weeks of life, I already hated him (he'd assumed we'd have at least until puberty before the disrespect set in). My exchanges are often quite sarcastic, and evidently my particular brand of conversation is not to everyone's liking.

"Oh, no, I don't think you can do it," were my roommate's words upon my informing her of my plan. My eyes had already rolled skyward as I began a standard sarcastic reply, before I realized that it was no longer allowed. It was the season of Lent, everyone around me was practicing self-deprivation, and although I was not raised with religion, I was intrigued by the idea of trying to change a behavior of my own. And so I decided to spend a week without sarcasm. Or, more accurately, I attempted to. As I soon discovered, I was so used to acting a certain way that it was difficult to change, and some derisive comments slipped out almost subconsciously. The biggest difference was that now they were immediately followed by, "I'm sorry, that was sarcastic". There were some conversations I found myself forced to avoid altogether, such as a discussion of Jersey Shore, or anything concerning cafeteria food. I was surprised by the amount of censoring I found myself engaging in—for each sarcastic comment uttered on accident, there were ten more I had stopped in their tracks. I had never realized how much sarcasm I used every day.

As the week went by, I noticed an odd emptiness, edged with desperation. It was as though I had to hold all my discussions without using a solitary 'E', when every previous exchange involved the letter. However, over time, I noticed other characteristics beginning to float to the surface, compensating for what was missing. Perhaps they were picked up from observation of my less sardonic friends, and perhaps they were buried there all along, and were only presenting themselves now like the reds and golds of autumn leaves poking through in the absence of chlorphyll, but whatever the reason, without sarcasm I found myself being nice. And not just nice, but nice like a girl—giggling and looking up through my lashes like the effort of raising my head was just too much to handle. I was compensating through the automatic formation of new patterns, and that week, despite the awkward way I talked now that I was editing myself, and a complete lack of change in any other part of myself, I was called "cute" multiple times.

On the one hand, this is offensive. Why should I be more desirable when I was repressing a part of myself? Particularly when I was then exchanging it for something so clichéd and, some might say, demeaning? On the other, athough I may be a tad begrudging about it, it's not difficult for me to see why reducing the amount of acid I spewed on a daily basis would make me a more enjoyable person to be around. I would like to believe that it was the subtraction of sarcasm, and not the addition of giggliness, that changed things. There were times, before I forced myself to become more self-aware, that I didn't even notice I was tearing people down; there's a thin line between mean-funny and just plain mean, and I now found myself far better suited to acknowledge and carefully navigate it.


Welcome William Joseph LaBanca


