North Branford K9 "Hanz" Receives Ballistic Vest

Sgt. Mario Bernardo has been a member of the North Branford Police Department since 2006. With the addition of his K9 partner Hanz in 2013 they have teamed together and provide a new level of service and protection to the residents of North Branford. Hanz is a two year old German Shepherd and graduated from the Conn. State Police K-9 Academy in Dec. 2013 after 16 weeks of training.

The North Branford Police Department's K9 Hanz has received a ballistic vest thanks to a nonprofit organization, Vested Interest in K9s, Inc., and Connecticut Color Breed Association fundraiser for Vested Interest in K9s, Inc. in Glastonbury, CT. The vest will be embroidered with the sentiment "This gift of protection provided by Vested Interest in K9s, Inc".

Vested Interest in K9s, Inc. is a 501c (3) charity located in East Taunton, MA whose mission is to provide bullet and stab protective vests and other assistance to dogs of law enforcement and related agencies throughout the United States. Each vest costs \$1050.00 and has a 5 year warranty. The nonprofit was established in 2009 to assist law enforcement agencies with this potentially lifesaving body armor for their four legged K9 Officers. Through private and corporate sponsorships, Vested Interest in K9s, Inc. provided over 1546 law enforcement dogs in 49 states with protective vests since 2009 at a cost of over \$1.4 million dollars.

Vested Interest in K9s, Inc. announces their signature tank top is now available online for a \$20.00 donation at www.vik9s.org. Proceeds will provide bullet and stab protective vests, for police dogs actively working without the potentially lifesaving equipment.

The organization orders the U.S. made vests exclusively from distributor Regency Police Supply in Hyannis, MA who also does the custom embroidery on the body armor. Vests are manufactured by Armor Express in Central Lake, MI.

New K9 graduates as well as K9's with expired vests are eligible to participate. The program is open to law enforcement dogs who are US employed, certified and at least 19 months of age.

Student Data Privacy



The legislative session doesn't begin again until February 2016. Over the next few months, I begin my outreach within the district to see if improvements are needed in certain laws. I believe in the next legislative session, student privacy will become an important issue.

In 2015, the Education Committee raised a bill to address student

privacy; however, the bill never reached the House floor for a vote. When schools contract with businesses for certain purposes, similar to when we sign up for a credit card or buy something on-line, sensitive personal data is collected. For instance, when our students purchase a yearbook, they'll fill out forms and submit information that these vendors obtain. Nothing under state law protects the third party from disclosing this information.

Before the first day of school, I realized how bad this could be. Because of clerical delays with the bus company, we did not receive our children's bus schedules in the mail before school started. Many of us went to social media, like Facebook, to find out if anyone had information, and a parent posted that we could obtain our child's bus route on-line by going to the bus company's website.

After visiting the website, I was shocked that any person, through a searchable database, could obtain whole bus route information for any single bus route, pick-up and drop-off times for specific households, and whether a student is receiving a "special needs" bus. All of the information was readily obtainable by anyone through the internet without any password protection. Even more troubling was that this information was posted without prior notice to our board of education and administrators who quickly had the information removed from the website.

Connecticut has made great strides in promoting school safety and has expended grant monies to help fortify our schools. Creating a database that allows anyone to gather entire bus routes throughout school districts seems to fly in the face of our public safety protocols, and I believe parents and students have a right to have this information protected. While Connecticut General Statute Section 1-217 requires certain information to be protected from the public, including personnel, medical, or similar files, the law does not specifically protect against the disclosure of student information that is obtained by a third party vendor. I believe the company's actions in allowing this information to be accessed by anyone over the internet does not follow the spirit of the law, and certainly, the legislature needs to protect disclosure of information without prior permission from the school district.

The internet has dramatically changed our lives and opened windows of information. In this modern age, Connecticut must protect against the disclosure and sharing of student information, and I will strive to get this law passed in the next session.


I should have had a few more Bloody Marys.



It's About the Land

The North Branford Land Conservation Trust, Inc.

We hear the word 'invasion' a lot these days. It is used in different contexts; military invasion, invasion of privacy, home invasion, and to describe a natural phenomenon of the plant kingdom, when invasive species take over and drive out native plants and wildflowers. Each context has an underlying common theme—each represents an unwanted or undesirable encroachment, an action which upsets, changes or destroys something we treasure.

Recently the North Branford Land Conservation Trust, Inc. has discovered instances where a few adjoining landowners may have unwittingly invaded or encroached upon one of our properties. The land trust owns about 230 acres of land set aside for the protection of open space in 50 separate parcels. Many of these parcels are small, scattered about town, often bordering residential neighborhoods. You may be unaware that the piece of land bordering your back or side yard is owned by the land trust. Over the past three years, the land trust has begun to inspect and mark the boundaries of its landholdings. With its all-volunteer staff, work parties are formed to go out on weekends or early evenings to inspect property lines of land trust property.

The field inspections have revealed a problem. In several instances adjoining landowners have encroached on land trust property by cutting down trees, filling low lying areas, piling brush, discarding unwanted items such as old tires and scrap lumber, and other pieces of 'junk', or parking vehicles and trailers. Even structures have been found on land trust property. More commonly, adjoining land trust property is used as a garden or extension of a lawn.

As a land trust, the preservation and conservation of our open space property is a duty and responsibility we try to uphold. That's because we are stewards of land protected for public benefit and enjoyment. Should our inspections reveal an encroachment on land trust property, we will notify the adjoining owner and schedule a meeting to discuss the issue and seek an amicable resolution. So before undertaking a tree clearing project next to a wooded area, check the location of your property's boundary. We look to our neighbors to help us protect the land. Become a member. 

Young Adult Inspires Fight Against Digestive Diseases

When Angela Cafarelli was asked to be an Honored Hero this year for the Crohn's & Colitis Foundation of America, she was totally shocked. She thought about her fellow sufferers and thought sharing her story as an Honored Hero will actually help people living with Crohn's or Colitis.

Growing up, Angela felt as normal as a young girl should. She was extremely energetic, loved to play sports, be outside any chance she got, and hang out with her two older sisters. "My parents would always make a joke that I couldn't sit still for 2 minutes. But that was me, always wanted to explore."



Even though Angela was an active child, throughout her childhood she frequently had stomach issues such as pain, constipation, diarrhea or vomiting. The years went by and the symptoms would come and go, some worse than others, but she kept trying to live her life as though she was a normal girl. Angela hated being the girl who couldn't just order anything off the menu at a restaurant with friends or needed to know where the closest bathroom was in any location. "It became a game when my family and I would walk into a store. 'Angela, where is the bathroom located?' and 99% of the time I knew."

Then, before Angela knew it she was off to college. Her worries were different. She prayed the cafeteria food wouldn't make her sick and hoped her dorm room was closest to the bathroom. Her stomach seemed to take a turn for the worse. Angela could barely eat and had shooting pains in her lower right stomach that wouldn't go away. She had her first colonoscopy at the age of 18. The procedure confirmed Angela had Crohn's disease in her small intestine.

Receiving a diagnosis of and living with a chronic disease can be an emotional rollercoaster. For Angela, it's extremely important to have a support system. This is one of the reasons she has chosen to participate in the Crohn's & Colitis Foundation's Take Steps Walk. Her family and friends walk in her honor and to help her fight back against her illness. Angela states, "Take Steps helps everyone to feel good inside and out."




