EDITORIAL

The Legislature Giveth... Bureaucrats Taketh Away?



You may have heard: the legislature recently passed a bipartisan bill that takes a small but meaningful step toward easing your electric bill. It's not sweeping reform—but it's a start.

Some of the key reforms address a long-standing controversy: ratepayers being forced to cover utility bills of other customers. The legislation addresses that

burden. It caps energy usage for participants in the Low-Income Discount Rate (LIDR) program and requires annual re-certification to ensure only eligible households receive the benefit. It also uses state bonding to pay down unpaid utility balances—resetting arrearages to pre-pandemic levels and easing the pressure on paying customers. Additionally, the bill shifts certain costs—like funding for electric vehicle charging stations for passenger cars—out of the "public benefits" charge on your monthly bill and into bonding.

The result? A modest savings—just a few dollars a month at most. But the noteworthy development: This was a rare bipartisan effort to shift certain costs from legislative policy decisions off your monthly bill. On a complex, often divisive issue, that's real progress.

But that progress is already under threat.

On July 9th, the Public Utilities Regulatory Authority (PURA)—the state body that oversees electric rates—advanced a plan directing utilities to create a program to support electric charging stations for medium- and heavy-duty vehicles like trucks and school buses. The \$8 million cost? You guessed it: ratepayers will foot the bill through the public benefits charge.

And there's more.

In Fairfield County, United Illuminating (UI) has applied to launch a \$300 million project to replace aging transmission lines currently attached to railroad infrastructure. Local officials and residents in Bridgeport and Fairfield are pushing back—objecting to the use of above-ground monopoles and suggesting the lines be buried underground instead.

Here's the problem: burying those lines would be significantly more expensive. And due to complex regional energy rules, every ratepayer in Connecticut—regardless of where you live or who your provider is—would

end up paying for the extra \$500 million it's projected to cost. Once again, that cost would hit your monthly bill through the public benefits charge.

The Connecticut Siting Council, which oversees this kind of infrastructure siting, took a straw poll vote rejecting UI's current plan. If the Council formally rejects it, the project could shift to the more expensive underground option—sending electric bills even higher for all of us.

These two developments—one rooted in California-inspired green energy mandates previously supported by the Governor and legislative Democrats, the other in local opposition to infrastructure changes—undermine the bipartisan progress we just made in late spring.

We took one step forward on lowering electric bills. Now we risk taking two steps back.

All Italian - All Good

Pizza Dough Saga by Mark Hehl

Connecticut has the highest per capita population of Italian Americans in the USA. Our pizza is award winning. Here is a childhood recollection of a local Italian American who grew up in an Italian enclave during the 1950's.

My mother always cooked and did it well. There was spaghetti sauce on the stove simmering on many days; yes, just like in the movies. I can still remember the wonderful smell of tomatoes and garlic. Buying the best ingredients was important to her. She would go to various stores or send me to buy specific fresh foods. Different stores for beef, pork, pizza dough and the live market for fresh chicken. Some stores were far from home. Being the oldest, I was always the one who rode my bicycle to buy these special foods. One hot summer day, I was sent to buy pizza dough. On the way back home, my friends called to me saying: "We need one more for a stickball game, come play." I resisted but they kept tempting me and even



held on to my bicycle. It worked, as I did join in hoping to just play for a short time. Losing track of time during this intense street competition, the dough, sitting in the hot sun, expanded, broke the bag, and oozed out between the rungs of the bicycle basket. I did my best to bring the mess into the house. It was falling out over my arms. To say the least, I made another trip to the store and came directly home this time. I did not want to face the consequences from my mother a second time during the same day. I do not remember the details only that my experience was not pleasant. Italian mothers tend to be intense and emotional. I grew up on the receiving end of this many times.

Only once did I get lazy and purchased another item at a more local store and thought that she would not know the difference. It did not work; I got caught! After my mother finished with her verbal scolding, which lasted a long time, I never even thought about doing it again. Each time after that incident I went to the store that I was told to.

Hazwaste Central is open for the season Safe & Free Disposal of Residential Household Hazardous Waste

The Regional Water Authorities' HazWaste Central will be open on Saturdays until mid- October. They are closed Labor Day weekend

HazWaste Central helps area residents in member towns protect water quality by safely disposing of household wastes. Located at RWA at 90 Sargent Drive in New Haven, HazWaste Central is open from <u>9 a.m.</u> <u>until noon on Saturdays only</u>. Household hazardous waste comes from everyday products used in the home, garage, yard or garden.

A visit to HazWaste Central is quick and easy. Participants never have to leave their cars, and the waste is off-loaded by professionals. Some of the household wastes that can be dropped off include aerosol cleaners and sprays, antifreeze, oil-based paint and pool chemicals. We also list some of the accepted items on your yellow trash information card.

In Connecticut, recycling is state law! This means that everyone must recycle.

That includes all residents whether living in a single or a multi-family building, every business including non-profits, and all public and private agencies and institutions, including all public and private schools and local and state government agencies. Visit RecycleCT to learn about the benefits of recycling right.

Connecticut schools must recycle right along with other municipal agencies, residents and businesses. This act has been in effect since January 1, 1991. It is important not only that schools make certain that their program

- Glass and Metal Food and Beverage Containers
- Plastic Containers* #1, #2, #3, #4, #5, #6, #7

• *No black plastic, nothing smaller than 2"

- Waste Oil (crankcase oil from internal combustion engines)
- Motor Vehicle Batteries
- Scrap metal
- Corrugated cardboard, boxboard, newspapers, magazines, office paper
- Leaves (must be composted)
- Grass Clippings (banned from disposal should be left on the lawn or, if necessary, composted)
- Ni-Cd Rechargeable Batteries (from consumer products)

The law requires your hauler to provide a warning notice to customers suspected of violating separation requirements and to not knowingly mix designated recyclables with trash.
