Benches Awarded from **Plastic Film Recycling Program** Two benches were earned by NB from the Trex Company as part of the

Plastic Film Recycling Program. These are the fourth and fifth benches NB has earned in the two and a half years of the programs existence. We have surpassed the 10,000 pound mark of plastic film collected and recycled. WOW!!!.

The fourth bench was awarded, earlier this year, to Atwater Library for the six-month period from July 2018 through December 2018.

The Town's fifth bench was earned by Town Hall for the first half of 2019. They quickly donated it to the Park and Rec and Senior Center, so they will now have a bench for each of their two bocce courts.

Even though plastic shopping bags are being banned in many towns or there will now be a charge, for getting them from the store, there is still enough plastic film to make the program sustainable.

In the last six months or so, Guilford Fence has joined the program, as we have been collecting the plastic film their fencing is shipped in.

Thanks to everyone who participates in the Plastic Film Recycling Program and please continue to be diligent in placing only acceptable items in the collection bins. That will help greatly when sorting the material.

EDITORIAL

State Representative Vincent Candelora Breaking Down the Plastic Bag Tax



Public Acts 19-117, Section 355, which goes into effect on August 1, 2019, creates a statewide plastic bag fee of .10 cents per "single-use checkout bag" that must be collected by retailers making sales in Connecticut. The collectors of this fee include a "store" defined as any retailer who is registered for Connecticut sales tax that

sells goods directly to the public and maintains a retail location in Connecticut that provides to its customers a plastic bag with a thickness of less than four mils that is provided by a store to a customer at the point of sale. These bags do not include re-useable plastic bags, bags on a continuous, perforated roll that are used to contain meat, seafood, loose produce or other unwrapped food items, newspaper bags, or laundry or dry cleaning bags. If a store charges for paper bags, they may keep those fees. Only a .10 cent fee for plastic bags is remitted to the state, and those charges will appear separately on a sales receipt. If there is no sale to the customer, the fee does not need to be collected so bags for promotional materials or unrelated to the sale are free.

The law gets confusing because on July 1, 2021, single-use plastic checkout bags are scheduled to be banned in the state; however, in addition to the tax for the next two years, municipalities may enact bans of plastic bags prior to that date. Municipalities also may enact or enforce an ordinance concerning single-use plastic checkout bags, provided the ordinance is as restrictive or more restrictive as the state legislation. In addition, municipalities may enact or enforce an ordinance concerning paper checkout bags, including, but not limited to, enabling each store to charge a fee for any such bag distributed to a customer. Any municipal that charges for a bag are subject to sales tax. If a municipality were to charge its own plastic bag fee, it would be in addition to the state plastic bag fee.

I believe the legislature should not have granted this extra authority to towns. Allowing them to ban bags in a town might not be a problem, but permitting them to create different and additional taxing schemes is cumbersome for businesses and creates a nuisance for them with little value. Legislators always fail to put themselves in the position of businesses to understand how they are impacted. Customers will likely get annoyed with a store if they cannot purchase a bag in Branford, but can do so in Guilford, or if a customer gets charged .20 cents for a plastic bag in North Branford and .10 cents for a paper bag in North Haven. The retail employees must now be equipped to explain why each town may have different laws pertaining to plastic and paper bags. The legislature should have applied this public policy universally throughout the state in consideration of the impact to



our retail market. Sadly, however, as usually, our business community was not taken into consideration. I hope, therefore, most communities will not attempt to create its own policies and allow for the ban to go into effect on a statewide basis.

Let's Be "Frank"

Congratulations my man. It looks like you have another tenant on your side of town. It was with great sadness that I read the news about the death of Joe DaCosta. I know you knew Joe and I know you guys are probably already talking about the rules of the game.

I worked on and off the field with Joe for many years and he was a special guy. As the umpire and chief of our Little League Board of Directors, Joe was always at Wall Field. We would meet on Saturday morning when there was inclement weather (which seemed like most Saturdays), to see if the fields were playable. As I would drag my butt out of my car, Joe would pop out of his car with his usual trifecta. His dog under his arm, a beer in the other hand and that ever present smile. He would walk the field, give me the thumbs up or down and I would call the coaches.

As the president of the league and a fellow umpire, I would attend Joe's classes for training the younger umpires. He would always tell them to respect the game, the coaches and the players. Always do your best. We all make mistakes. But most of all, know the rule book. "You can never get in trouble if you use the book. But you have to know it to use it successfully", I can still hear his instruction. Also, always maintain your composure.

Later, I probably did more than 100 Babe Ruth, AAU and high school baseball games with Joe. He was a bit younger than me but he was my mentor on the field as my umpiring career started much later in life than his. Between innings we'd talk about positioning, the strike zone and the pain in the ass coach or parent that happened to be giving one of us grief.

I particularly remember one guy giving him a hard time from the first pitch. Joe remained quiet until he called a player safe and the coach ran out to disagree. Before he got two feet out of the dugout, Joe turned and calmly explained, "Sir, it's 95 degrees out and I have three games today. I would like to get off the field as soon as possible and you don't do that by calling guys safe. So if I called him safe, you can bet he was safe". We never heard another word from that coach not only that game but every game we had him after that. Remember, always maintain your composure.

After your death, whenever I had a rules question I would call Joe. I had him on speed dial before speed dial was popular. He wouldn't only give me the rule but he would explain why, so I would know it for next time.

He was one of a kind. He always had the kids best interest at heart whether it was as young player or a young umpire. He didn't care what the outcome was as long as the kids were being treated fairly.

He once called me and asked me to pick a certain kid in the draft. My first question was about the talent level of this particular kid. "I'll be honest with you," he said. "He's not that good. He's shy and quiet but he's a great kid and he loves baseball. I'm afraid if someone else picks him he'll get lost in the shuffle and he won't have a good year."

In my younger days I was always about wins and losses, but I picked that kid as a favor to my friend. He was right. We didn't win any championship that year but at the end of the season when the young man thanked me for picking him and told me he had a great time, it made me happy that I made that decision and it was a great coaching lesson. I mentioned it to Joe every time I saw him and he would just give me that usual grin.

Joe was what youth sports should be about and more people like him are needed in this area. I learned more from him than any umpire I had the pleasure of being on the field with. On days when I was ailing, he would always "take the dish" and tell me to take a break. He always had my back on and off the field and when he told me he was taking a break as the Little League Umpire and Chief, that was the year I decided to move on and apss the torch.

Except for a few minutes running into him around town, I hadn't spent much time with Joe in the past few years and I regret that. We always talked about a reunion of the old Little League group but it never came to fruition, I regret that as well.

13 Stars and Stripes – a Symbol of Oppression?

On 9/15/16 the Washington Post reported that a Michigan school district superintendent declared that our first flag – Betsy Ross's 13-circular-star flag – is offensive and a symbol of exclusion and hatred, reasoning that it should be banned from football games because it was flown during times of slavery and adopted by white supremacists. Colin Kaepernick and others perpetuate this sentiment. Can we please awaken from this horrible distortion of our heritage?

Betsy Ross was a Quaker Abolitionist! Her flag was first flown in a battle at Cooch's Bridge, Maryland on September 3, 1777. Free African Americans were among the Continental Army in these battles for independence. Yes, free African Americans supported their state's separation from British rule. The Continental Congress integrated blacks into most of its military units. Crispus Attucks, the first to be killed at the Boston massacre, was an African American. Peter Salem, from Farmington, CT, joined his local militia and served for seven years. Free African Americans served as soldiers, guides, messengers, and even spies. Their combined man-hours were as much as 25% of the Patriots' strength.

Jefferson's original draft of our Declaration expressed Abolitionist motivations. He accused the British King of "[waging] cruel war against human nature itself, violating it's most sacred rights of life & liberty in the persons of a distant people who never offended him, captivating & carrying them into slavery in another hemisphere or to incur miserable death in their transportation thither. And determined to keep open a market where MEN should be bought & sold, he has prostituted his negative for suppressing every legislative attempt to prohibit or to restrain this execrable commerce." Though this language was excised by the vote of Southern states, it reveals a distinctly non-racist mindset.

True to Jefferson's sentiment, the northern states abolished slavery – by law in their new constitutions – within two decades of the Revolution's end. By 1810, 75% of all African Americans in the North were free and by 1840, virtually all were free. Those who voted for this emancipation were all white Christian men!

Our Stars and Stripes is a symbol of the freedoms these people sought. It is distinctly NOT a symbol of the slavery and oppression that our Declaration, Constitution and Bill of Rights eradicated. The principals of the Stars and Stripes are those that ended slavery, emancipated blacks and women and continues to this day to put a stop to discrimination and the oppression of minorities.

Many of my clients have what I would call an "If I die" attitude (at least in the beginning of our relationship). They plan or don't plan based on the fact that they "might" die (that's where the "if" comes in). The conversation typically goes something like this: "Well, if I die I would like my house to go to my daughter." I chuckle a little bit and usually say something like, "If you die... Oh, you are going to die!!"

In a way we are no different than a carton of milk in that we all have an "expiration date." Ironically, many people plan more for the expiring carton of milk than for their own expiration date. I have a few clients who honestly believe they are not going to die at all. They seem to be quite rational in all other ways but on the question of death they are swimming in denial. My question to them usually is "If you are immortal, why have you chosen New Haven county to live... forever?"

Death should not be dealt with as a distant abstract possibility, a dark horse candidate or a long shot. Your estate plan should reflect what happens when you die, not if you die.

So... what happens if you like swimming in denial and you don't make a plan? Fear not, the State of Connecticut has a plan for you. Because you left no direction, the State's intestacy laws will dictate where your assets go; and your assets may not go to who you think they would.

Some Say North Branford Is not a Rural Community

In January, at the urging of the State Director of Rural Development for Massachusetts, Connecticut and Rhode Island, North Branford Economic Development Coordinator Roger Salway applied for a State Grant. The grant was a \$14,300 grant which would match funds invested by the Town, to build agri-tourism in our rural community.

As Mr. Salway explained, " one of our goals is to attract visitors to our farm stands through a program to build a pollinator pathway by organizing a sunflower seed planting project which has attractant interest along Central Connecticut Corridor." In addition, the grant included funding for producing and distributing a destination North Branford video which focuses on our rural community. 50.9% of the total land in North Branford is Open spaces, including more than 40 active farms. With further suggestion from the District Director, Mr. Salway spent 3 days with the help of an intern and time taken by town Manager Mike Paulhus to fill out a dozen forms for this application. On July 5th, the town was send a letter of "Not Selected". The letter explained that the "Rural Business Development Grant funds must be used for projects benefitting rural areas or towns outside the urbanized periphery of any city with a population of 50,000 or more." It was determined that North Branford is not an eligible area making the application ineligible. Apparently North Branford is too close to New Haven, indicating it is not a rural community. In an attempt to get clarification, The Totoket Times called and received a voice message and a website to visit, explaining why we do not qualify. This is still under investigation and Mr. Salway is continuing to attempt to change this and the Times will continue to investigate it to see if this can have any effect on future grant applications.

Town Council and Board of Education selected

NORTH BRANFORD – The North Branford Republican Town Committee met this past week, endorsing candidates to run in this year's municipal election. Republicans currently hold the maximum majority on the Town Council allowed by the Charter by 6-3. Four Republican incumbents will seek re-election, and two new candidates will be on the ballot.

The Town Committee endorsed incumbents Michael Doody, Rose Angeloni, Tom Zampano, and Bob Viglione for a return to the Town Council, and two new candidates – Ron Pelliccia and Walter Goad to join them. Incumbent Councilors Al Rose and Anthony Candelora chose not to run for reelection this year. The Committee also endorsed incumbent Board of Education member Cynthia Rice for reelection.

"We have a great team of seasoned incumbents as well as some exellent new candidates this year," said Republican Town Committee Chairman Michael Downes. "Our team will continue working hard to hold the line on taxes, ensure our school system has the resources it needs, and keep North Branford a great place to live, work and raise a family."

The municipal election will be held on November 5th, 2019.

Lauren Munro is Moving On

After more than 20 years with our town's Parks & Recreation & Senior Center, Lauren Munro is starting a new phase in her life. Although excited about her future. Following the resignation of two members of her commission, Lauren resigned from her position as she felt that other comissioners were acting inappropriately as well as council/commission liaison. She didn't feel she could do her job to the ability that was required. A followup investigation by the town came to the "conclusion there was insufficient evidence of inappropriate behavior in meetings and outside of meetings".

Lauren leaves her position as Recreation Director with some sadness. "It was a pleasure doing a job which I never really viewed as a job. I wanted to give the best we could to the residents of this town. In doing so, I think I gave it my utmost attention, dedication and committment. My position was rewarding as I watched the Department grow and expand during my tenure and I was proud of what we accomplished," Lauren explained.

"There is not enough time or space to thank everyone who touched my life/heart over the past years. I owe thanks to so many including: my staff, my commission, the many festival supervisors and volunteers, Public Works Director Fran Merola, Other Town Departments, all our senior family at the community center and all who participated in all we provided."

Howevern, Lauren will just be going across town and staying involved in the community as she will be the North Branford Intermediate School Student Success Liason. Her duties will involve the following:

- Oversee the students in the school's Open Choice Program, in accordance with guidelines established by the school administration;
- Provide academic support and assistance as necessary in the school's Open Choice Program;
- Help students in the school's Open Choice Program identify appropriate behavioral and instructional strategies;
- Maintain communication with teaching staff regarding student academic and social/emotional progress of students in the school's Open Choice Program;
- Perform administrative tasks (e.g. student hall, lunch/bus duties, etc.) • as determined by the administration;
- Serve as a resource to other building programs (i.e. Life Skills, BRIDGES, ISS, etc.) as determined by the school administration.

"The North Branford Public School System is thrilled to have someone with her broad experience and passion for working with people," explained Superintendent of schools Scott Schoonmaker. "It will make her a great fit for our school population".

Taking Carre of your Sunflowers Many of you have joined us in planting sunflowers. We wanted to extend

a little ongoing advice in caring for them.

If your sunflowers are planted closer together than 1 foot apart, they will probably not grow as tall. Sunflowers grow best when they don't have competition for nutrients and space.

Mother Nature has been kind to us with all this rain. If it gets hot and dry, the plants will need a deep watering every few days. If you planted your sunflowers in a pot, they will need more water than those seeded directly in the ground. If possible, mulch your sunflowers to keep the soil moist. The mulch should not touch the stem to prevent rot.

It is a good idea to fertilize during the season, but they don't need very much. Any flower fertilizer will do, just read the package to see how much and how to apply. Too much fertilizer or not enough sun might create week stems.

If the area where the sunflowers are is windy, it could be a good idea to stake them. The seed heads can get very heavy. When tying the sunflowers to a stake, keep the string a little loose to allow for the stalk to grow. The stalk of the large sunflowers can become the size of your wrist. If your sunflowers have already leaned over, don't try to straighten them too much or you will weaken the stem.

I have noticed that the Japanese beetles like sunflower leaves. Unless they eat all the leaves or the flower head, the plant should be fine. I don't have any good advice against other critters.

The varieties of our sunflowers are: Dwarf Sunflower- Sunspot, tall Sunflower - Mammoth Gray Stripe.

We will be posting photos of growing sunflowers on our web page at destinationnorthbranford.com and there will be a photo exhibition in the fall. So take plenty of pictures along the way.

Children and Smoke Alarms

Sleeping children don't always awake when a smoke alarm activates. Children, ages 6 thru 10 seem to be most affected. While these dramatic facts are worrisome, we shouldn't allow them to obscure the fact that smoke alarms are highly effective at reducing fire deaths and injuries. Roughly 70% of deaths occur from fires in homes without smoke alarms or disabled smoke alarms.

Think about how heavily you or your children sleep. As loud as smoke alarms can be, sometimes children sleep through it. Research has shown that some children don't wake up from the loud beep of a typical smoke alarm.

There are many new types of smoke detectors and carbon monoxide detectors on the market today. Some of the new features include:

- Personalized Instructions, which allows you to record customized escape instructions
- Fire Drill Feature, which allows a time delay to simulate an actual fire alarm
- Loud 85 decibel outputs
- 10 year batteries

There have been many advances over the last 10 years in home smoke alarms. Smoke and carbon monoxide detectors are electrical devices and the do have a life limit. It's a good idea to replace your detectors every 10 years. We also want to emphasize the need to continue planning and practicing home fire escape plans and to insure everyone in your home can be awakened by the sound of the smoke alarm. We will continue to reinforce the importance of developing and practicing a home fire escape plan during which the smoke alarm is activated so all family members know its sound.

Sleepover fire safety for kids

Is your child safe staying overnight at a friend's home?

Think upset tummies and lack of sleep are the biggest risks when your child is spending the night at his or her friend's house? Before you permit your child to sleep over with a friend, talk to the child's parents. Depending on what you learn, it can either uncover serious fire dangers or give you peace of mind during your child's sleepover.

8 out of 10 fire deaths take place in the home, with the majority of home fire deaths occurring late at night. "If you don't know for certain that the friend's home is equipped with working smoke alarms, and that the sleepover will be supervised by an adult, don't take the risk; reverse the invitation and have the sleepover at your own home.

Teach children about the importance of fire escape planning in a positive, nonthreatening style. Ideally, your child is already well versed in home fire escape planning and drills in your own home. Before you permit a sleepover at a friend's, discuss the importance of knowing how to escape from a fire wherever you are, including friends' homes. Have your children ask friends and their parents about fire safety in their home, and to report to you anything that makes them feel unsafe.

And when it's your turn to have other children stay overnight in your home, make sure they know what your home's fire escape plan is.
