"I HAVE A DREAM"

Speech reprinted in honor of Doctor King

I am happy to join with you today in what will go down in history as the greatest demonstration for freedom in the history of our nation.

Five score years ago, a great American, in whose symbolic shadow we stand today, signed the Emancipation Proclamation. This momentous decree came as a great beacon light of hope to millions of Negro slaves who had been seared in the flames of withering injustice. It came as a joyous daybreak to end the long night of their captivity.

But one hundred years later, the Negro still is not free. One hundred years later, the life of the Negro is still sadly crippled by the manacles of segregation and the chains of discrimination. One hundred years later, the Negro lives on a lonely island of poverty in the midst of a vast ocean of material prosperity. One hundred years later, the Negro is still languished in the corners of American society and finds himself an exile in his own land. And so we've come here today to dramatize a shameful condition.

In a sense we've come to our nation's capital to cash a check. When the architects of our republic wrote the magnificent words of the Constitution and the Declaration of Independence, they were signing a promissory note to which every American was to fall heir. This note was a promise that all men, yes, black men as well as white men, would be guaranteed the "unalienable Rights" of "Life, Liberty and the pursuit of Happiness." It is obvious today that America has defaulted on this promissory note, insofar as her citizens of color are concerned. Instead of honoring this sacred obligation, America has given the Negro people a bad check, a check which has come back marked "insufficient funds."

But we refuse to believe that the bank of justice is bankrupt. We refuse to believe that there are insufficient funds in the great vaults of opportunity of this nation. And so, we've come to cash this check, a check that will give us upon demand the riches of freedom and the security of justice.

We have also come to this hallowed spot to remind America of the fierce urgency of Now. This is no time to engage in the luxury of cooling off or to take the tranquilizing drug of gradualism. Now is the time to make real the promises of democracy. Now is the time to rise from the dark and desolate valley of segregation to the sunlit path of racial justice. Now is the time to lift our nation from the quicksands of racial injustice to the solid rock of brotherhood. Now is the time to make justice a reality for all of God's children.

It would be fatal for the nation to overlook the urgency of the moment. This sweltering summer of the Negro's legitimate discontent will not pass until there is an invigorating autumn of freedom and equality. Nineteen sixty-three is not an end, but a beginning. And those who hope that the Negro needed to blow off steam and will now be content will have a rude awakening if the nation returns to business as usual. And there will be neither rest nor tranquility in America until the Negro is granted his citizenship rights. The whirlwinds of revolt will continue to shake the foundations of our nation until the bright day of justice emerges.

State Representative Vincent Candelora



The 2024 legislative session begins Wednesday, Feb. 7, and while dealing with fiscal matters is the chief mission for the three-month period, there is space in the process to tackle other issues.

The state’s nonpartisan Office of Legislative Research just issued its annual “Major Issues” report, which summarizes some of the topics that could color committee rooms of the General Assembly.

Election administration and security is a topic identified in the report, and I agree that it’s a critical issue that should be addressed as soon as possible. After all, our Secretary of the State, Stephanie Thomas, recently issued a highly unusual warning to Bridgeport residents, urging them to vote in person during a re-do of the Democratic mayoral primary because the absentee ballot process could (again) be compromised. With that said, bolstering the integrity of that process is a priority for me—I intend to again push for the removal of the absentee ballot drop boxes that were at the heart of the Bridgeport ballot stuffing case, while also calling for mandatory jail time for criminal election violations.

While an issue such as ballot fraud, or even juvenile crime, garner headlines and some form of legislative action, less-heralded topics are on the agenda. For example, licensing agreements that can limit a public library’s access to eBooks. Or residents’ ability to save money by accessing telehealth services—including a policy change I favor, making it easier to access qualified out-of-state providers.

Over the next couple of weeks, I look forward to sharing more details about proposals from my caucus, House Republicans, as well as initiatives I’m submitting on my own.

With that said, I go back to where this column started. Budgetary matters are our chief charge, and I consider preserving the strict fiscal controls that have helped put our state on more solid financial footing to be my most important goal. There’s growing pressure from progressive lawmakers to loosen these revenue and spending management caps to free up spending on government programming.

We were able to spread some things out and enjoy it more. The bad news is with four days to celebrate, it was also four days of an eating festival. All that weight I lost is slowly creeping back but I am still in the good column and with the new year “un-resolutions” I will take it all back off and then some. It’s the first time I am optimistic about that.

Speaking of New Year’s, I was reflecting on the changes since we were kids. For many years we went to a house party at aunt Tess and uncle Rudy’s house. As kids it was always fun because bed time curfews were lifted, we got to make all the noise we wanted, play with our cousins and watch some of the older cousins and aunts and uncles (for lack of a better phrase), get drunk.

As we got older, we took our dates to this same party, taught them what family gatherings were all about and had a few (too many) drinks ourselves. We stayed up all night, playing games and bonded until the wee hours of the morning. Sometimes, we even had contests with the cousins to see who could stay up all night. If my date didn’t like the event, chances were she was gone by next year. If you don’t like my family, you don’t like me.

As time went on and the kids were young, the all nighters would end at about 1:00 or 2:00am. The ball would drop, we’d kiss and hug, dance to the Guy Lombardo band, warm up the car and say good night.

Then the kids got a little older. They too would come to the family gathering. They too would bring their dates. They too would drink a little (as we had slowed down). When the extended families started getting bigger and the aunts and uncles were all gone, the party started breaking down, We then started going to small house parties and we would always leave right after Dick Clark’s countdown. The parties were always close to the house and we were nestled snug in our beds well before 1:00am.

Then the house parties became a hassle and we decided to stay home. Cook some appetizers, have some nachos and watch Ryan Seacrest (not the same without Dick Clark) countdown. The beds would be turned down and we would be in bed by 12:02, only rustling to take the happy New Year’s wishes from our three kids.

This year, I checked with the kids and nobody had plans. My New York kid said he was staying as far away from Times Square as he could and the other two decided not to go anywhere. At 8:00 I turned on Dick Clark’s New Year’s Eve and after watching for an hour, I realized I did not know one of the entertainers. The music was giving me a headache so I went to bed at 9:00.

As I was laying in bed with further reflections, I thought, “It has happened, I have turned into my parents”. Upon further reflection, I realized, “It was worse than that”. Our parents, up to their death stayed up until the ball dropped. Dad died 9 days after New Year’s and he was awake at the family party for his final New Year’s Eve.

I haven’t figured out what all this means, but it is obvious that times have changed. I don’t know if it is for the good or bad. I had the opportunity to go to a Sons & Daughters of Italy New Years eve party and I did not go. I wasn’t upset because I didn’t go, I was upset because I chose not to.

Yes brother, times have changed. Again, I’m not sure if it’s for the good or bad but after retiring at 9:00 New Year’s Eve, I do know that this was the best I have felt on New Years’s Day in a long time.

As for resolutions, you know I never make them. I no longer feel that it’s a special time. It’s just another day. The older we get, the more important each day becomes. No resolutions but I do try to follow that great Jimmy Valvano quote, “If you laugh, you think and you cry, that’s a full day. You do that seven days a week, you’re going to have something special.

Happy New Year and I’ll see you soon.

King continued

But there is something that I must say to my people, who stand on the warm threshold which leads into the palace of justice: In the process of gaining our rightful place, we must not be guilty of wrongful deeds. Let us not seek to satisfy our thirst for freedom by drinking from the cup of bitterness and hatred. We must forever conduct our struggle on the high plane of dignity and discipline. We must not allow our creative protest to degenerate into physical violence. Again and again, we must rise to the majestic heights of meeting physical force with soul force.

The marvelous new militancy which has engulfed the Negro community must not lead us to a distrust of all white people, for many of our white brothers, as evidenced by their presence here today, have come to realize that their destiny is tied up with our destiny. And they have come to realize that their freedom is inextricably bound to our freedom.

We cannot walk alone.

And as we walk, we must make the pledge that we shall always march ahead.

We cannot turn back.

There are those who are asking the devotees of civil rights, "When will you be satisfied?" We can never be satisfied as long as the Negro is the victim of the unspeakable horrors of police brutality. We can never be satisfied as long as our bodies, heavy with the fatigue of travel, cannot gain lodging in the motels of the highways and the hotels of the cities. **We cannot be satisfied as long as the negro's basic mobility is from a smaller ghetto to a larger one. We can never be satisfied as long as our children are stripped of their self-hood and robbed of their dignity by signs stating: "For Whites Only."** We cannot be satisfied as long as a Negro in Mississippi cannot vote and a Negro in New York believes he has nothing for which to vote. No, no, we are not satisfied, and we will not be satisfied until "justice rolls down like waters, and righteousness like a mighty stream."1

I am not unmindful that some of you have come here out of great trials and tribulations. Some of you have come fresh from narrow jail cells. And some of you have come from areas where your quest -- quest for freedom left you battered by the storms of persecution and staggered by the winds of police brutality. You have been the veterans of creative suffering. Continue to work with the faith that unearned suffering is redemptive. Go back to Mississippi, go back to Alabama, go back to South Carolina, go back to Georgia, go back to Louisiana, go back to the slums and ghettos of our northern cities, knowing that somehow this situation can and will be changed.

Let us not wallow in the valley of despair, I say to you today, my friends.

And so even though we face the difficulties of today and tomorrow, I still have a dream. It is a dream deeply rooted in the American dream.

I have a dream that one day this nation will rise up and live out the true meaning of its creed: "We hold these truths to be self-evident, that all men are created equal."

I have a dream that one day on the red hills of Georgia, the sons of former slaves and the sons of former slave owners will be able to sit down together at the table of brotherhood.

I have a dream that one day even the state of Mississippi, a state sweltering with the heat of injustice, sweltering with the heat of oppression, will be transformed into an oasis of freedom and justice.

I have a dream that my four little children will one day live in a nation where they will not be judged by the color of their skin but by the content of their character.

I have a dream today!

I have a dream that one day, down in Alabama, with its vicious racists, with its governor having his lips dripping with the words of "interposition" and "nullification" -- one day right there in Alabama little black boys and black girls will be able to join hands with little white boys and white girls as sisters and brothers.

I have a dream today!

I have a dream that one day every valley shall be exalted, and every hill and mountain shall be made low, the rough places will be made plain, and the crooked places will be made straight; "and the glory of the Lord shall be revealed and all flesh shall see it together."2

This is our hope, and this is the faith that I go back to the South with.

With this faith, we will be able to hew out of the mountain of despair a stone of hope. With this faith, we will be able to transform the jangling discords of our nation into a beautiful symphony of brotherhood. With this faith, we will be able to work together, to pray together, to struggle together, to go to jail together, to stand up for freedom together, knowing that we will be free one day.

And this will be the day -- this will be the day when all of God's children will be able to sing with new meaning:

My country 'tis of thee, sweet land of liberty, of thee I sing. Land where my fathers died, land of the Pilgrim's pride, From every mountainside, let freedom ring!

Branigan is a former town manager and municipal department head with over 30 years of combined local government experience in New York and Connecticut. A graduate of Providence College with a Bachelor of Arts Degree in Political Science, he holds a Master of Public Administration degree from the University of New Haven.

In his spare time and for the past two decades, Branigan has served as the President of Kids for Kids, Dancing for Life, Inc., an all-volunteer non-profit organization dedicated to raising funds for children in medical or financial need.

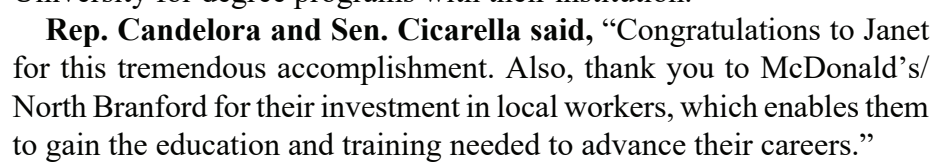

KINDERGARTEN REGISTRATION

Scott Schoonmaker, Superintendent of North Branford Public Schools, announces that Kindergarten registration for North Branford residents with children eligible to enter school in the fall of 2024 will be as follows:

All school registrations must be completed **solely online**. Registration will be open from February 5 – February 9, 2024.

PLEASE NOTE: Registrations will not be considered complete until all information on the registration form is verified and all required documents are provided and verified including proof of residency, birth certificate, immunization records and health assessment records (HAR-3). You may be required to bring in your child’s original birth certificate as well as your proof of residency documents.

On February 5th please visit our website <https://jerome.northbranford-schools.org/> and click on the “New Registrations” button. Here you will see detailed directions on the registration process.

In order for a child to be registered in Kindergarten, the following requirements must be met:

- The child must be five (5) years of age on or before September 1, 2024.
- Beginning in the 2024-25 school year, the date for Kindergarten entry has changed.
- Any child who is not five years old on or before September 1, 2024 will generally be admitted to kindergarten under the following conditions:
- Parents/ guardians must submit a written request to the building principal, Beth Parker
- Email: eparker@northbranfordschools.org
- Mailing address: 335 Foxon Rd, North Branford, CT 06471
- Parents/ guardians will make their child available to participate in an assessment to ensure that “admitting such a child is developmentally appropriate”.
-
- The original birth certificate, with seal, has been uploaded and examined by the principal or designee.
- Your child must have a current physical exam; **one that was completed after September 1st, 2023**. The physician and the parent must complete the State of CT Health Assessment Record. The form must be **on file** with the school nurse **prior** to the first day of Kindergarten unless alternative arrangements have been made with the building principal.
- The child must physically reside in North Branford/Northford.
- Proofs of residence have been uploaded, examined and approved by principal or designee such as: deed to home or dated rental agreement, escrow papers or signed mortgage commitment, current utility or telephone bill, and/or notarized letter from landlord or owner acknowledging parent/guardian’s and student’s residence.

If you have any questions, concerns or problems during the registration process, please call 203.484.1235.

In addition, if you have specific concerns about your **preschool** child’s development, please call 203.484.1235 for information.

You should have received an Orange 2024 Recycling/Trash Card in your last issue of the Totoket Times. Please keep this card handy all year. It has important dates and information that you will need concerning your trash pickups and what can be recycled. If the card was missing or you misplace yours, there will be copies at both libraries, public works, STW Community Center and Town Hall. You can also download a copy from the town website.

Did you know that there is a 10-cent deposit on:

All glass, metal and plastic drink containers that contain 150ml to 3 liters of a carbonated beverage and 150ml to 2.5 liters of a non-carbonated beverage.

Malt-based hard seltzers were added to the list of covered beverage containers in 2023. The law excludes other spirit or wine-based beverages that are not malt-based.

Please remember:
PLASTIC BAGS SHOULD NOT GO INTO THE BLUE RECYCLE BIN.

If you bag your recyclables to bring them to the blue bin, please dump them out of the bag into the blue bin and then bring the plastic bag to a plastic film drop off location. The plastic bag gets tangled into the machinery and stops the workflow.

Here are some statistics on North Branford’s plastic film collection.

December 2023 = 417 lbs.

All of 2023 = 5244 lbs. This is the largest ever collected over the last 7 years!

That’s over 15 tons of plastic film taken out of the waste stream!!
